#### Item 4. REVP Report

The REVP presented her National Board of Directors (NBoD) report for October 2011 – January 2012, which included her schedule.

This report is a listing of activities that have occurred in the PSAC Ontario Region.

Below you'll find the report as presented.

The REVP's office has expanded as of October 31, 2011 with the hiring of an Executive Assistant. The successful candidate, Cleo Reid, is a welcome addition to the PSAC Ontario Region.

#### **Collective Bargaining**

Currently PSAC Ontario Region has many bargaining units who are in various stages of the bargaining process.

#### Highlights of Ongoing Negotiations

- On Dec. 6, 2011 there was an information meeting for TC members working in the Hamilton Niagara and Greater Toronto Area in Toronto. The meeting began the process of identifying and setting up the Area Co-coordinators Structure.
- Bargaining team members for the FB group have been traveling throughout the Region to mobilize support and provide information on the FB contract negotiations. During these meetings the team has been collecting signatures for the FB petition.
- DCL 901 Post-Doctoral Fellows (PDF) bargaining team met with the Regional Negotiator to prepare for the negotiation of the local's first collective agreement. The PDF bargaining team began developing bargaining proposals, informed by a survey of current PDFs.

 The employers for the First Nations Police Civilians and Officers employed at Anishinabek Police Service (APS) and Nishnawbe-Aski Police Service (NAPS) are challenging the jurisdiction of the Public Service Alliance of Canada union certifications under the Canada Labour Code. The Canada Industrial Relations Board has considered their jurisdictional objection and PSAC is now in the submissions process.

# **Provincial Election – Oct. 6**

Harper's Conservatives and Mayor Rob Ford had predicted a "hat-trick" with the election of a Hudak Conservative government as inevitable. PSAC Ontario strategically identified seven primary and secondary ridings to mobilize the membership in support of candidates who were supportive of public services. The election results within these ridings were clear: NDP gained 3 seats; LIB lost 3 seats; and 1 seat remains held by the PC Party. As a result the NDP now holds the balance of power in a Liberal Minority Government.

This electoral result was achieved in part through the work of PSAC members who volunteered their time to engage our members and the public during this election. By targeting key ridings and ensuring voters were well informed on party platforms in regards to; worker rights, health care, childcare and affordable post-secondary education, PSAC members helped to turn the tide.

In addition, the PSAC Ontario website was used to present a Provincial Election Members' Toolkit, which was developed to get members directly involved by providing the tools necessary to effectively lobby their MPP's. Also, a "Protect Public Services" YouTube video was created to highlight how our members have been rallying against cuts across the region.

As part of PSAC's Fightback plan we will continue to pressure Members of Provincial Parliament over the next 4 years on maintaining and enhancing public services by getting the membership politically engaged.

#### **Mobilization**

The Occupy Movement has been part of our effort to get the membership engaged in a movement that represents the struggles of poor and working class people. PSAC Ontario members have participated in various Occupy rallies throughout the Region since the movement expanded from its American roots internationally on Saturday Oct. 15. When Occupy Toronto was evicted on Nov. 23, 2011, PSAC members were the last to leave St. James Park. Members' responded to appeals by Occupy Toronto to remain throughout their eviction to ensure their safety from an overwhelming police presence.

The PSAC Ontario Region is now on Twitter (@PSACOntario) in an effort to further mobilize and inform the membership and engage with young members. The Region has also begun a Flikr account (PSAC Ontario) to store and highlight our event photos for members to easily access.

On 19 October 2011 members of PSAC's Ontario Council and Greater Toronto Area Council supported the MUNACA campaign by getting the message out about the unfair treatment of non-academic staff. Members handed out flyers to potential students and their parents at recruitment sessions at Lawrence Park Collegiate Institute and Northern Secondary School in Toronto to support MUNACA workers.

On Dec. 3-4, 2011 PSAC Ontario held its first ever DCL First Nations Police Services Conference. This conference brought together the First Nations Police Civilians and Officer Locals employed at Anishinabek Police Service (APS) and Nishnawbe-Aski Police Service (NAPS) and Treaty Three Police Service Officers to begin to work and strategize together. Through the conference the locals decided to form a Council to strengthen their collective voices with their employers.

#### Fightback Campaign

We have finalized dates and locations for the Stewards Assemblies as part of our fightback initiative. The Stewards Assemblies have been designed to engage members to become politically active with sections on lobbying and PSAC's campaigns, including; Mental Health, CFIB and Third Choice campaigns. Members from Components will be educated on their rights under the WFAA in an effort to prevent further job cuts to the public sector.

PSAC Ontario has continued to collect signatures for the Tony Clement petition at all events including education courses, rallies and meetings. At the Ontario Federation of Labour's Convention (Nov. 21-25, 2011) PSAC issued a challenge to all participants in attendance to complete one full petition sheet in 24 hours. We received a great deal of petitions in response to this challenge and CUPE Ontario,

CUPW and USW agreed to take the petition back to their membership.

To place the pressure directly on Treasury Board President, Tony Clement we held a rally outside the Sheraton Centre Hotel in Toronto where the Minister was delivering a speech to the Canadian Club of Toronto (Oct. 31). We received press from City TV and the Minister began to follow PSAC Ontario on Twitter due to our online social media coverage of the event.

CEIU Ontario activists have engaged an ongoing battle with their department to stop the job cuts and office closures. Rallies have been conducted across the region and include rallies on Oct. 18 in Hamilton, Oct. 20 in Oshawa, Oct. 29 in Niagara Falls and Dec. 16 in Sturgeon Falls. We have received favourable press for these rallies and the public and our labour allies have been very supportive.

For the CFIB campaign, a member was brought in for 3 weeks to coordinate the distribution of materials to the regions, publicize the campaign and to begin to engage with local businesses. To continue to mobilize our membership around this campaign we are including this initiative within our Stewards Assemblies.

PSAC Ontario has been active in promoting the Third Choice campaign through distribution of the campaign business cards, endorsements by Ontario Council representatives and through our social media (Facebook and Twitter). Also, the campaign has a direct link on the PSAC Ontario website featured prominently on the main page.

# **Education**

An Advanced Stewards Course was held in London from Oct. 27-30, 2011 and in Kingston from Nov. 3-6, 2011. During the Kingston Advanced Stewards Course on Nov. 5, 2011 participants held a rally outside Veterans Affairs to protest the recently announced cuts.

A Local Officers Advanced Training was held in Barrie from Oct. 27-30, 2011.

A Workers Health and Safety Centre Level 1 advanced education course was held in Sudbury on Nov. 17-20, 2011.

#### **Labour Movement/ Solidarity**

In an effort to strengthen our relationships with our allies we have attended several events including:

Toronto Rally to Defend City Services and Jobs - On September 26, 2011 PSAC members joined thousands of community members and workers speaking out for city services in a mass rally at Toronto City Hall.

PSAC was in attendance to support the Ontario Network of Injured Workers' Groups and Toronto Injured Workers' Advocacy Group during their rally for Injured Workers. This was the 20th Annual Christmas Demonstration at the Ministry of Labour in Toronto, which took place on December 9th, 2011.

The Coalition of Black Trade Unionists (CBTU) Ontario Chapter held its 15th annual awards dinner, dance and fundraiser, where Sharon DeSousa (REVP-Ontario) and Larry Rousseau (REVP-NCR) were keynote speakers. The function was a huge success with representatives from every major union in attendance including the CLC, OFL and community groups such as the Asian Canadian Labour Alliance, Latin American Trade Union Coalition and Justice for Migrant Workers. NDP Member of Parliament, Olivia Chow accepted on behalf of her late husband Jack Layton the CBTU Annual Leadership Humanitarian Award.

The Ontario Federation of Labour held its 11<sup>th</sup> biennial Convention on November 21-25, 2011 at the Sheraton Centre Hotel in Toronto. There was strong participation from PSAC members who voiced their views on the policy papers and resolutions presented, which will shape the OFL's mandates for the next 2 years.

The British Columbia Federation of Labour invited Sharon DeSousa to speak on a three person panel at their Union Renewal Conference on Nov. 29, 2011. The Conference was a means to discuss the challenges facing the labour movement, including how to engage

racialized and aboriginal workers. Sharon spoke on the highlights of PSAC's commitment to equity and human rights, including PSAC's recent victory of the Canada Post pay equity case.

#### **Equity and Human Rights**

The four PSAC Human Rights committees (RWC, RVAC, MDAC, Aboriginal Circle) held a jointly sponsored event on International Human Rights Day (Dec. 10). This event was cosponsored to increase solidarity between the various equity group members through a human rights framework of commonality.

This initiative will continue next year, as members recognized the importance of continuing to work together.

The Ontario Region remains a very active region supported by a dynamic collective of staff.

#### **Staff - Appreciation**

I wanted recognize the contribution of Travis Lahnalampi who worked as a Term Secretary in the Toronto Regional Office for the month of January backfilling for Marcia Maliwat who was on leave.

I can report that Kim Beemer accepted a new position with Federal Mediation Services. Kim was the first Regional Negotiator within the Ontario Region. I wanted to recognize the significant contribution that Kim made through the negotiation of a number of collective agreements including a first collective agreement at Queen's University. We wish her well in her new endeavours.

Bruce Flannigan completed his term Regional Representative assignment ending November 11<sup>th</sup>, 2011 where he worked on the CFIB campaign along with other duties that arose during this time period.

#### **Staffing - New Hires**

A permanent job vacancy has been posted for purposes of replacing Kim Beemer. Interviews will commence in March.

Nicole Wall has been hired as a term Regional Education Officer commencing March 12<sup>th</sup>, 2012 to July 13, 2012 to backfill for Shirley Riva who will be taking a short term leave of absence. Nicole brings a significant amount of labour education experience to this term position. Nicole is currently the term **National Education Officer** where she has been working since January 2011 at national headquarters on various initiatives including the development, design and update of national educational materials. Nicole also worked as a **Labour Educator** at the Labour Education Centre in Toronto from June 2007-December 2010; **Partnerships Coordinator** at the Toronto Training Board, April 2005-June 2007; **Special Projects Coordinator**, Ontario Health Coalition, Toronto and **Special Projects Organizer**, Canadian Labour Congress, 2002. Nicole is also a community activist involved in the Justicia 4 Migrant Workers campaign. Nicole will play a key role in the Regional Education Program including continued preparations for Fall School and other regional activities. Nicole will be working in the Toronto Regional Office.

PSAC has filed applications to hire 1 summer student in each Regional Office within the Ontario Region through the Canada Summer Jobs program. Last year none of our applications were accepted; consequently, the hope is that at least one of our applications will be approved this year.

There have been no other staffing changes since my last Report to Regional Council

#### Unionware

The membership module of Unionware is now live. The membership module is designed to replace our pre-existing MOCHA membership system and provide a state of the art centralized database to store membership information. Currently each of the five (5) regional offices maintains separate membership databases for updating contact information for Local Presidents, Committees, participants in education courses along with other relevant membership information. Now that the Unionware system is live each Regional Office will start use the new integrated Unionware system instead of each of the independent databases to track event information. Currently an organizing module, membership module, events module and WSIB are all live in Unionware.

#### Renovations

The renovations within the Toronto Regional Office are nearly completed with a fully integrated design to replace the prior patchwork layout of the office. Feedback was provided from the MDAC committee which has been forwarded to PSAC Holdings with a view to ensuring that the office is accessible to all members.

PSAC Holdings is in the process of investigating a new potential office location in Sudbury. The current lease expires this year. A potential site under consideration is located at. 754 Falconbridge-Hwy; Unit 2; however, no final decision has been made.

#### Item 6. Ontario Council Strategic Plan

# 2012 PSAC Ontario Council Strategy Plan

During the PSAC Ontario Council meeting in November 2011, Council decided on 6 priorities for the upcoming year based on the information from Council's membership survey. Through these 6 identified priorities the following strategy plan was constructed, to guide Council's actions for the 2012 year.

The identified priorities are integrated; with a focus on political action due to the Conservative Government's cuts to public services. These cuts are a direct threat to our membership and the overall Canadian public.

The 6 priorities that were identified by Council were: Political Action, Education, Collective Bargaining, Health and Safety, Equity and Human Rights, and Communications.

#### **Political Action**

With the Conservative Government holding a majority, the public sector has been targeted for widespread cuts. Members have expressed concern for their jobs and for the protection of public services. In coordination with PSAC's Fightback plan, Ontario council will undertake the following actions:

#### **Actions**:

- Making our members aware of their rights to lobby and travel with them to MP and MPP constituency offices
- Helping members with writing letters to the editor and op-ed pieces
- Raising public awareness over the cuts to public services and thereby shifting public opinion and gaining media attention through demonstrations
- Bringing members out to demonstrations and mobilizing community support
- Working to strengthen our coalitions with community groups, affiliates, District Labour Councils and social justice groups by participating and promoting their events

#### **Education**

Members have identified education as a key priority in defending public services and good quality jobs. Achieving a politically mobilized membership requires members who are educated on their rights and knowledgeable on social justice issues.

- Promote the Education program and schedules
- Promote learning opportunities to Local Executives and activists to ensure broad distribution

- Increase awareness of Ontario Council through the PSAC education program by having council members drop in
- Review alternate means of delivery of education to improve cost efficiency

#### **Human Rights and Equity**

Respect and inclusion of human rights and equity issues is paramount in creating an inclusive union and overall labour movement. By identifying and challenging barriers to participation we can build on our union's strength.

#### **Actions:**

- Promote Equity and Human Rights days and work on arranging events and recruiting members to participate
- Identifying and developing social justice fund projects
- Promoting and mobilizing members around progressive human rights legislation (i.e. Trans Rights legislation)
- Endorsing PSAC human rights campaigns by providing materials to members and getting directly involved through campaign actions

# **Collective Bargaining**

The Conservatives have created a hostile bargaining climate by interfering in the negotiating process through regressive back to work legislation. In light of this, collective bargaining must be done strategically to build upon our collective strength.

- Promoting and supporting all bargaining within PSAC
- Having standing item at ever Ontario Council meeting
- Promoting the need to bargain Health and Safety language directly into collective agreements, ensuring workers safety is a top priority
- Advertising the social justice fund to connect collective bargaining with our commitment to social justice initiatives

- Helping to build networks to share information on what's happening within sectors
- Highlighting achievements to keep locals informed on the gains that have been made
- Working to engage young workers in the collective bargaining process

#### **Health and Safety**

It is vital that we continue to educate our members on Health and Safety. This will help to prevent members from injury and to ensure that members who have experienced an injury or live with a disability are treated with dignity and respect.

#### **Actions:**

- Through collective bargaining, table demands for a Joint Learning Initiative in collective agreements
- Help members to initiate joint health and safety committees and promote these as an avenue for workers to ensure the safety of their workplaces
- Work to educate members on their rights and responsibilities through their collective agreements
- Increase awareness among members of Health and Safety Courses and Training opportunities

#### Communication

Good communications with members is vital in mobilizing the membership and sharing information.

- Semi-annual Regional Newsletter to update members, with the first addition being an introduction to who Council is and what they do
- Continue to use membership surveys to gain members input
- Get Regional stories in PSAC National's "Union voice"
- Work within our constituency to gather members personal email to increase our email tree network
- Submit letters to the editor and op ed pieces

The REVP recommends that the document be amended and resend out to council so that they can review and input their comments.

#### Item 8. Ontario Council Reports and Guidelines

The REVP stated some reports have been received with postnominals. As all minutes are reviewed by the membership, and with the understanding that post-nominals will act as a barrier, since access to higher education is a privilege. Therefore, the decision was made to not include post-nominals in Council reports.

Below you will find the Ontario Council Report Guidelines that were distributed to all Council members as part of their meeting package.

#### **Ontario Council Report Guidelines**

Each member of the Ontario Council must provide a quarterly report to the REVP on the objectives, activities and future plans of that Council member for their constituency. **Please note that reports are due 2 weeks prior to council meeting**.

Your report should be in point form format, 1 page in length and in Arial - 14 point font. The report should focus on your activities for the period preceding the following Council meeting and describe your goals for the next 4 month reporting period.

The breakdown of your report should comprise 3 sections, which include:

**Objectives** – This section should be an outline of what you hope to achieve for the following period until your next report. It should link to your future plans.

**Actions** – A listing of the actions/activities you took part in and their purpose, with regards to your objectives. Actions should be dated, however, they are not meant to be a detailed account of each of the activities that took place in that time period. This section is meant to demonstrate how you are trying to fulfill your objectives and/or future plans.

**Goals** – What you plan to do and how you plan to do it. For example if one of your goals is to promote the committees of PSAC Ontario, you should state what you plan to do to achieve this goal.

#### Timelines:

- **1.** Council Committees must be finished their reports and REVP reviews reports before committee members leaves.
- 2. Meeting Minutes will be out 1 month prior to next meeting.
- 3. Digital file of materials for council meeting will be sent out 1 week prior to council meeting (paperless). Exception of council member who request paper due to accommodation.
- 4. Portfolio expenses are due 2 weeks prior to council meeting, Expenses will not be paid unless Council Reports are received.

#### Item 10. Recruitment for weekend Courses

The Chair would like all Council Members to be actively recruiting members within their Region to attend PSAC Regional courses.

#### Item 11. Ontario Council Members Reports (Appendix "F"):

Sister Souad (Sue) Soubra is requesting when there is training for Council if it can be done on another day, because it becomes tiring for Council members to work through their lunch after sitting for 3 meetings in a row.

The Chair recognized that due to the training being added to this Council meeting it would mean an extensively ambitious agenda. Hence, a motion was made to Council on a conference call prior to Council to continue with the training and the current agenda, with the understanding that this would be extensive sitting hours.

The Chair recommends that next time Council has training the vote will be to either add a day to Council or postpone agenda items.

Point of Privilege – Brother Ralf Bucherer states that he has created a Facebook page to speak on issues and give information surrounding the National Triennial Convention.

# Item 12. PSAC National and Regional Fight-Back Plan

# **Local Presidents and Stewards Assemblies**

The Chair stated Federal Budget Watch events would be taking place in all the Regional Offices, to have members engage directly. The District Labour Councils in partnership with the PSAC Area Councils would hold federal budget watch events in different regions also.

The Chair stated the PSAC Ontario Region had been holding Local Presidents and Stewards Assemblies across the province. Each session included standardized materials, yet each provided slightly different and unique focuses based on local realities. The sessions were designed to cover the needs of each area and politicize the membership.

The Assemblies were carried out in either 3 hour or full day modules. The full day modules had the afternoon sessions devoted to Workforce Adjustment Training. The 3 hour evening sessions included Mobilization and Lobbying on PSAC campaigns.

Brother Rejean Amyotte stated that the feedback he has received had been very positive in regards to all Assemblies. Members found the Assemblies to be informative.

#### Item 13. Communications- Media and Lobbying Training

PSAC developed a Lobbying Kit to help members get politically engaged by speaking with their local Member's of Parliament (MP) and explaining the importance of public services. Ontario Council received a 1 hour training module on lobbying their MPs and were given the Lobby Kit as a resource for their use.

Ontario Council members also received media training in a 1 hour module. The module consisted of crafting a key message when speaking to the media, body language/posture, and techniques on delivering an effective interview.

# **Ontario Council Newsletter**

Council discussed the creation of Council's first newsletter, which would be a general introduction of Council's makeup, functions, roles and responsibilities. The newsletter would be kept strictly as a council

newsletter and would be completed and distributed prior to next Council meeting.

Motion that Christo Aivalis takes the lead on working on the newsletter and Melanee Jessup will assist on the project.

#### **Ontario Council Youtube Challenge**

Council discussed the logistics of the Council Youtube Challenge. Due to the upcoming PSAC National Triennial Convention, Council decided to postpone the release of the competition until after convention.

# Item 14. <u>PSAC National Triennial Convention (Jerome Turcq-Chair of Finance)</u>

Brother Turcq, the PSAC National Finance Committee Chair, discussed how the PSAC National budget was assessed using two criteria; the number of members and the average wage of members. The Committee used a threshold of 170,000 members as a conservative estimate to base financial estimates. Should PSAC membership fall below this number of 170,000 members, there would be a levy imposed if approved at Convention. The Committee looked at the impact that this levy would have on PSAC's finances and concluded that this would mean membership dues would have to increase.

Brother Turcq stated that the PSAC National Budget that was presented to the Alliance Executive Officers included no dues increase. Also, Brother Turcq stated that PSAC had 3 months worth of savings to cover expenses and all liabilities currently.

However, Brother Turcq identified that there was a major issue with the National Budget. PSAC Holdings Inc., the PSAC entity that is responsible for all rental and property ownership of the PSAC, had an operating deficit which has been continuing for years. Over the course of the last twenty-five years there has been an accumulation of repairs needed to be done to PSAC headquarters, that will cost about \$5 Million. Should PSAC consider selling its headquarters, it would still require making these necessary repairs first.

A second issue with the PSAC National budget that Brother Turcq identified surrounded the PSAC employee pension plan shortfall and reporting changes. Due to possible changes in legislation in terms of pension plan reporting, the PSAC may have to address the issues stated below.

#### Forecast for the next 5 yrs with the employee pension plan

- Using the smoothing out reporting method we could postpone dealing with the financial shortfall until 2015 of approximately \$30 Million. However, changes in legislation may require us to address this shortfall all at once, instead of a progressive pay off time scale
- If by 2013 we can still file positively I would recommend that we do file but there is no guarantee there will be a positive balance.
- This plan does not have anything to do with the Supplemental Pension, this is a promise that was made to PSAC employees.
- Finance Committee develops the costing solutions to the resolutions that the committees brings forward. The committee members have the right to challenge the committee chair on the costing.

The Committee looked at ways to improve upon efficiency and the AEC is looking into different ways to cut back on expenses.

#### **Members Plan**

The Chair stated that at the last NBoD meeting a motion passed that the Members Plan would not be debated at the PSAC National Triennial Convention. Instead, the Plan would be presented to the delegates at Convention and would become part of the PSAC Strategic Plan for the next three years. Also, the resolution stated that for the 2015 PSAC National Triennial Convention a Members Plan would be presented to the Delegates for debate.

#### Item 15. Labour Day

The REVP's office created a standard proposal template that will be used by all Area Councils for accessing Labour Day funding.

Template is Exhibit "A"

# Item 16. PSAC Ontario Region Travel Policy for Educational Courses

The Chair asked the PSAC Ontario Acting Regional Educational Officer, Nicole Wall to draft a policy which will be sent to the educational committee to make the final recommendations. This will help the Regional Offices when they are putting members in travel status.

The educational line item of \$25 per diem that members receive for attending a weekend course will be increased to \$50. This is already factored into the line item for PSAC's National Triennial Convention.

Sister Nicole Wall will also develop a document that will explain how the consultation process works between staff and council members.

#### Item 17. New Business

# **Hotel for Council Meetings (Brad Feraday)**

At the last Council meeting, Council members agreed to be more inclusive of all council members regardless of the area in which they live.

Sister Vicki Pine suggested that it should be left up to the Council members that live in the GTA if they want to stay in the hotel or not.
