#### Item 3. <u>Business arising from previous Minutes</u>

Brother Kingsley was provided a laptop. It was allocated to the Ontario Council Equity and Human Rights Committee but has never been used. The Laptop has been updated and Skype has been installed on it. Sister Judy Philips will have her computer up and running by next meeting. Sister Debbie Willett requires paper copies for future meetings.

In regards to the video campaign, we received only one video proposal from Sister Mary Jeyananthan, we did not receive any from Brothers Ralf Bucherer and Brad Ferady. The proposal was

postponed because members wanted focus to remain on PSAC's Third Choice online campaign.

Recognizing the contributions of previous REVP's, the chair will be contacting all previous REVP's to invite them to the opening ceremony of the new Toronto Regional Office. The Chair is suggesting the pictures of the previous REVP's be placed in the new PSAC boardroom and framing is costed out at approximately \$20.

A motion was made to donate \$1000 to Brenda Walsh from PSAC Ontario Regional Council, she was very appreciative. The local and the labour movement are very supportive of her cause.

The REVP wants to thank the members of council and the community for taking part in the Labour Day events. There will be a debrief later on concerning what we can improve and what was done well.

Southwestern Area Council Summit requested a tool kit be developed so members can know what they can or cannot do during an election. A tool kit was developed and was sent out via email to all Area Councils, Committees and Local Presidents. Also it was posted on the website.

#### Item 4. REVP Report

The REVP handed out her schedule for the past few months as well as her NBoD report for June 3 – October 2, 2011.

This report is a listing of activities that have occurred in the PSAC Ontario region for the period following our last PSAC National Board of Directors Meeting.

The REVP's office has expanded as of September 19, 2011 with the hiring of our new Political Communications Officer. The successful candidate, Lino Vieira, is a welcome addition to the PSAC Ontario Region. Also the Executive Assistant position has been filled Sister Cleo Reid was the successful Candidate. She is a member of CEIU Local 638.

#### Collective Bargaining

Currently PSAC Ontario Region has many bargaining units who are in various stages of the bargaining process.

Highlights of Ongoing Negotiations

- UNE Local 358 is in bargaining with Atomic Energy Canada Limited.
- The Postdoctoral Associates are in negotiations with the University of Western Ontario for their first collective agreement. This employer has been reluctant to resolve issues at the table. PSAC has launched an on-line petition on our national website to encourage members to support their bargaining team by sending a message to the employer demanding a fair contract.
- The James Bay Hospital and Weeneebayko hospital were amalgamated. The new hospital is called WAHA (Weeneebayko Area Health Authority) and PSAC is in the process of negotiating a first collective agreement.
- DCL 501 at Blue Water Bridge has begun negotiations.
   Members used a recent MP visit to lobby for better working conditions.
- UNDE Local 650 in Trenton is in negotiations with Sunlite Cleaners.

Tentative Agreements (ratification dates to be scheduled)

- UNE Local 394 has reached a tentative agreement with the Canadian Centre for Occupational Health and Safety.
- UNDE Local 000636 has reached a tentative renewal collective agreement for contract cleaners working at CFB Borden.

 DCL 818 Commissionaires at CFB Kingston have reached a tentative agreement for a first collective agreement.

- DCL 901 Teaching Assistants and Teaching Fellows at Queens University ratified their agreement on June 26, 2011.

• UCTE members employed at Canada Ports Corp., Prescott ratified their renewal agreement on September 7, 2011.

#### **Provincial Election**

The Provincial Election is being held on October 6, 2011. All PSAC Ontario Area Councils, Committees and members have been busy engaging their communities and promoting our "Protecting Public Services" message. The PSAC Ontario Regional website has a 2011 Provincial Election link. This link contains an election toolkit developed for our members to ensure they are educated on the relevant issues and on their political rights. PSAC Ontario has also started a Twitter page, whose focus has been on getting the membership out to vote for Public Services. Communications materials (fightback flyer, Think Public Fans with an election message, letter from the REVP and a candidate questionnaire) have also been developed. These materials have been distributed through all Labour Day activities in the region as well as a mail out to all Committees, Local Presidents, Area Councils, etc.

In consultation with the Ontario Federation of Labour, PSAC Ontario has targeted the following Primary Ridings: Timiskaming—Cochrane, Thunder Bay—Atikokan, Bramalea—Gore—Malton, Scarborough—Rouge River.The Secondary Targeted Ridings are: Windsor West, Hamilton Mountain and Oshawa. Membership lists have already been sorted by targeted ridings to facilitate an outreach strategy. Recent polls indicate that this election is wide open - this is our chance to make a difference and stop a Hudak-Harper Alliance.

PSAC Ontario has made engaging the youth one of our priorities in this Provincial Election.

Nicole Beaulieu is a student who was brought into the Sudbury Regional Office through the Youth Placement program that PSAC Ontario has been involved in for several years. Nicole was reported in 2 local newspapers; the "Sudbury Northern Life" and "Sudbury Star", as a PSAC youth organizer who successfully lead a group of fifty activists on a march to help end the erosion of public services and to raise community awareness on this issue. Chants of "protect human rights" and "make your voice count" echoed through the streets of downtown Sudbury. High tuition fees, the cuts to public services and childcare are key issues for young people in this election.

#### **Mobilization**

We are mobilizing our PSAC Ontario membership around the potential cuts to public services and layoffs of our members. To accomplish this task we have been promoting our "Think Public" and "Fightback" campaigns at all PSAC events, education courses, community and Labour Day activities throughout the region. Currently mobilizing activities are occurring throughout the region in support of Parks, CFIA, FB, TC and SSO negotiations. For example, on August 3<sup>rd</sup> until August 5<sup>th</sup>, 2011 FB Mobilization conference was held to support contract negotiations.

#### Fightback Campaign

Between the Kingston Blues Festival, Kingston Labour Day parade, Toronto Labour Day Parade, Toronto Stop the Cuts Mass Meeting, Windsor Fair and Youth march in Sudbury, PSAC (Ontario) has collected in excess of 1,500 signatures on the Tony Clement

petitions with more petitions being signed at each Union event. This is a good start; however, our Region intends to continue to obtain signatures to support the goal of over 150,000 signatures nationally by the end of October.

PSAC is fighting back against cuts to public services and our Region recently won an important victory for members working at Atomic Energy Canada Ltd. (AECL). Local President Kirk Cooper in a joint statement with the employer confirmed that there will be no layoffs of PSAC bargaining unit members employed at AECL. PSAC represents 75 design technologists/specialists at AECL, more than 50% of whom were at risk of losing their jobs following the Harper Government's decision to sell AECL to the Montreal-based engineering giant, SNC-Lavalin.

CEIU Ontario activists have engaged an ongoing battle with their department to stop the job cuts to term positions. Rally's have been conducted across the region. For example, PSAC members rallied on September 12 outside their federal government worksite in Richmond Hill. Led by Cathy Malone and the members of Local 569, the lunchtime rally was designed to raise awareness of the Harper government's cuts to public services. PSAC Ontario will continue to support all members engaged in this fight.

#### **Education**

The first ever DCL Stewards School was held on July 19-22, 2011. The purpose of the school was to increase the capacity for Directly Chartered Locals to service and represent their members effectively. This initiative also coincides with PSAC's "Year of the Steward" campaign to build the capacity of our Union's base. Each participant of the school received a DCL Stewards Toolkit to assist them in representation upon arrival at their worksites.

On July 25 and 26, 2011, PSAC Ontario Regional Council came together for intense regional training on their roles and responsibilities as leaders within the region.

#### **Labour Movement/Solidarity**

PSAC members supported the Canadian Union of Postal Workers strike by joining picket lines across the Region. I spoke at a solidarity rally in Toronto hosted by the Toronto and York Region District Labour Council and participated on picket lines in Ottawa, Hamilton and Toronto.

OPSEU Rally – The rally was held on Sept. 13, 2011 for striking OPSEU college support workers from Georgian, St. Clair, Durham, St. Lawrence, Mohawk, Niagara, Centennial, George Brown, Humber, and Seneca Colleges. The REVP for Ontario was one of the speakers at the rally with several PSAC members participating. On Sept. 18, 2011 a tentative agreement was reached by OPSEU for more than 8,000 community college support staff in Ontario, ending an 18 day strike.

#### **Equity and Human Rights**

PSAC participated in Pride events throughout the Ontario region. Pride events are a great way for our members to show solidarity with the LGBT community. In less than a month we were able to participate in the Toronto Parade (the largest in North America) with Sister Karen Church, Brother Patrick Tanedo and PSAC Toronto Regional Staff attending this event. We placed Radio Ads and a YouTube video (prepared by Brother Patrick Tanedo) to ensure PSAC's visibility in support of the LGBT community. PSAC (Ontario) also participated in the Pride parades in: Thunder Bay, Sudbury, Windsor, Kingston and London Pride.

#### Item 5. Regional Office – Updates (Christopher Wilson)

The Ontario Region remains a very active region supported by a dynamic collective of staff.

#### **Staffing - Appreciation**

I wanted to start by recognizing the significant contribution of term officers who have completed their terms since my last report to Regional Council.

Alison Braley worked as a term Regional Representative in the London Regional Office for the period August 15<sup>th</sup> to October 14<sup>th</sup> for purposes of backfilling Todd Woytiuk who was on leave. Alison was assigned to the first contract negotiations for Postdoctoral Associates at the University of Western Ontario along with her other assignments. Alison worked with campaign organizers Peter

Ferguson and Ruchi Bella to support mobilizing efforts to an historic first collective agreement for postdoctoral associates at the University of Western Ontario.

Selvakumar Kandasamy worked as a term Regional Organizer in the Toronto Regional Office until September 23, 2011 for purposes of backfilling Michelle Sweeney who has been assigned to the McGill University strike. During his term, Selva successfully brought our campaign to organize postdoctoral fellows at Queen's University to a successful conclusion with a new certificate for this group. The bargaining unit description for which PSAC was certified is the most broad based bargaining unit description for postdoctoral fellows in Canada which will provide PSAC with a solid foundation to negotiate a first collective agreement.

Nicole Beaulieu worked as a student organizer in the Sudbury Regional Office until September 30, 2011. During her term, Nicole led a successful campaign to mobilize the youth vote in the Provincial Election. PSAC received widespread news coverage of our youth vote campaign.

Judy Kovacs worked as a term Administrative Assistant in the Thunder Bay Regional Office until September 30<sup>th</sup>, 2011. Judy was backfilling Sandra Goodick who was hired as a term Regional Representative until September 30<sup>th</sup>, 2011. Judy maintained the office while Sandra and Judith Monteith-Farrell worked together to service and represents the membership. Sandra's term assigned was created to support Judith Monteiths efforts to negotiate a renewal collective agreement for the Nishnawabe-Aski Police Service Board along with her other duties.

Leslie Searl worked as a term Regional Representative for a period of one month ending June 30, 2011 to backfill for Doug Koskowski during the competition period for his backfill assignment. Leslie supported FB mobilization efforts.

#### **Staffing - New Hires**

The following staff have been hired since my last Report to Regional Council

Lorraine Diaper transferred into the term Regional Representative Position in the Toronto Regional Office for purposes of backfilling Doug Kosakowski who is on leave. Lorraine has assumed the assignments previously assigned to Doug Kosakowski.

Mary Anne Laurico was the successful candidate for the term Regional Representative position in the Kingston Regional Office for purposes of backfilling Lorraine Diaper during her acting assignment in the Toronto Regional Office.

Bruce Flannigan was hired as a term Regional Representative for the period October 24<sup>th</sup> to November 11<sup>th</sup> to support our CFIB campaign along with other duties that arise during this time period.

Norbert Wenzel was hired as a term Regional Representative in Sudbury Regional Office for the period August 1<sup>st</sup>, 2011 to December 2<sup>nd</sup>, 2011 to backfill Jawara Gairey who is backfilling for Tom Hamilton.

#### Unionware

The membership module of Unionware was launched live on October 17<sup>th</sup>, 2011. The membership module is designed to replace our current MOCHA membership system and provide a state of the art centralized database to store membership information. Currently each of the five (5) regional offices maintains separate membership databases for updating contact information for Local Presidents, Committees, participants in education courses along with other relevant membership information. In time, the objective is to replace each of these independent databases with a single integrated Unionware system. Currently an organizing module, membership module, events module and WSIB are all live in Unionware. Each RO will continue to maintain concurrent databases until the transition is complete.

#### Renovations

The Toronto Regional Office is undergoing extensive renovations which once complete will include a new large boardroom for use for Regional Council meetings, committee meetings and other membership events. The new office will also include a small boardroom that will have pass card access for members or Locals who need access to a meeting space either during or after office hours. The new office will have a fully integrated design to replace the current patchwork layout of the office.

PSAC Holdings is in the process of investigating other potential office locations in Subdury to re-locate the Sudbury Office once the current lease expires in 2012. No final decision to either renew the existing lease or re-locate has been decide

#### Item 6. Ontario Council Strategic Plan

On November 4, 2011 Ontario Council worked on developing a strategic plan which will cover the course of their term of office.

#### **Health & Safety Committee Report (Appendix "A"):**

Bob Black, Chair of the Health & Safety Committee presented the Committee's report.

The Health and Safety committee suggested that the theme be Mental Health. This theme was unanimously endorsed due to the concerns over the upcoming cuts to the public sector and its effects on our membership. This theme also coincided with PSAC National's Mental Health Matters campaign.

A discussion took place on whether one Health and Safety Conference should be done as opposed to multiple regional conferences. Due to time and budget constraints the decision was made to have 1 Health and Safety conference in 2012.

The REVP is recommending that the proposal be deferred as she will be working with Brother Bob Black on the proposal. Once completed, an email will be sent out to council next week Friday requesting a response from council on the proposal by Tuesday.

Hospitality room is suite 1600: Opening unknown

Committees have changed from the past; with equity members now sitting on committees other than equity. The education/health and safety committee now have a voice from more diverse members than before. People can now both be apart of equity and education; which we feel is good

Input from Regional staff for training courses. Both Debbie (Toronto) and Réjean (Sudbury) have been contacted and asked for opinion on the matters for fall courses. Some regions argue that they were not consulted.

Also a big issue is training for members in the Kingston region is usually far away from the Kingston area. The staff did not accommodate workers in places like Cornwall, because they feel it is not cost-effective. It is felt that it is actually cheaper and fairer to bring

classes to these members, especially when we consider travel and lodging costs. Course scheduling is often insensitive to rural members with concerns like hunting. It was the belief that classes would not be undertaken without consultation of regional representatives and we were concerned this was not always happening

We agreed that education must start with basic education like TUB and Grievance Handling, but we need to push for more advanced courses. In some cases, we must look beyond pure cost-effectiveness.

We also suggested that perhaps we should back up and have a basic presentation to better understand the issues at hand, than seek to focus on more particular issues. The committee agreed to have Shirley and Debbie introduce the basic issues comprised in the education plan found on the Ontario PSAC website.

We went over the last cycle's budget in a detailed manner, looking at each line and what they mean. Regarding RO budgets, various trainings, remote subsidies, council training, OFL-CLC subsidies, supplies etc... Differences in RO budget based on some regions having many more members. Also looked at many of the ways in which the budget lines are either insightful/misleading.

We also went over basic statistics, including how many members were trained and in what particular course type. 1502 members trained over last cycle; though many may be multiples.

Money must better stretched; and that we have to ensure that when collective agreements cover training, we ensure that *they* pay for it, not the union; this would allow us to spend money on other members without such provisions. Despite the difficulties regarding getting employer-funded courses running, it is still a good idea to shift that money to other members; employers dragging their feet could mean that we have to get these members trained somehow.

We need to find a balance, and better lobby the employer to utilize the funds earmarked for specific courses. We all agree that collective agreements must have teeth to enforce the offering of these classes. Perhaps we need to offer courses to all, but hammer home the point that many already have employer funds allocated to them, long term we can hopefully ensure a stronger use of our funds.

We discussed numbers of courses, and we discussed how the PSAC accommodates lower numbers when important.

Other regions have a good system, where the course offerings are scheduled in the long term, and this helps plan budgets, and allows people to get TUB's so they can take higher level classes.

Getting our plans implemented may be difficult to get installed in all the RO's. Our committee cannot fully dictate policy to the RO's, but we can work through the REVP and Regional coordinator to make more systemic changes.
