Item 3. <u>Business arising from previous Minutes</u>

Brother Chris Wilson stated that he received the information from Ottawa in regards to the different bargaining units, their achievements, impasse and walk away from the bargaining table. Brother Wilson has forwarded the information to the REVP for review, once the review is completed it will be posted on the Regional website.

The lease for the Sudbury Regional Office is for 5 years and PSAC Holdings have an option to renew which given what we invested we will no doubt renew for another 5 years.

Also Brother Wilson reported back to Council in regards to the automatic door opener for the large boardroom doors. The Chair of the committee using the boardroom will need to advise security to unlock the accessible doors.

Brother Bob Black will be providing each Council member with a copy of their portfolio budget balance for period ending November 2012, as per request made by Sister Souad (Sue) Soubra at the last Ontario Council meeting in June.

Item 4. REVP Report

The REVP presented her National Board of Directors (NBoD) report for May 2012 – August 2012, which included her schedule. This report is a listing of activities that have occurred in the PSAC Ontario Region.

The REVP advise Council that the NBoD met and had a discussion as to where the organization is heading. The NBoD has since drafted up a statement which will be released once all the members of the board signs it.

Below you will find the NBoD report as presented.

Collective Bargaining

Highlights of Ongoing Negotiations

- On May 8, 2012, members from two locals (DCL 603 and NHU 00021) that work at the Weeneebayko Area Health Authority in Moosenee voted to become one local in an affiliation vote, becoming DCL 603. Currently, the local is negotiating a renewal agreement, which will cover the redefined bargaining unit.
- On April 24, 2012 PSAC filed for conciliation for DCL 802 Commissionaires at Lester B. Pearson airport. Strike votes were conducted on May 8th and 10th, 2012, with the membership overwhelmingly supporting strike action should the need arise. Conciliation dates have been scheduled for the fall.
- Members from Treaty Three Police Service (DCL 410) voted down a final proposal from the Employer on June 2, 2012. The group will now be heading into arbitration.
- IMP Group Limited, Aerospace Division has recently been awarded a 3 year contract. In 2010, I.M.P. closed its operations at Canadian Forces Base (CFB) Trenton and laid-off PSAC members working at the base. The last negotiated Collective Agreement between I.M.P. Group Limited Aerospace Division, at Canadian Forces Base (CFB) Trenton and the Public Service Alliance of Canada has a term of duration from July 1, 2010 to June 30, 2015. Therefore, with the recently awarded contract I.M.P has attained as mentioned above, PSAC is asserting our bargaining and representational rights as the certified, exclusive bargaining agent for the workers hired in Trenton. PSAC is currently waiting to hear from IMP on its position.
- On July 17, 2012 PSAC exchanged bargaining proposals with OMNI Facility Services Canada Ltd. (previously known as Koprash –Renfrew County – CFB Petawawa) UNDE Local 00639. The bargaining team will continue to negotiate with the Employer in the fall.
- On July 23, 2012 the Canada Industrial Relations Board issued a
 certificate to PSAC to officially represent members at the YQG Windsor
 International Airport. This local was previously recognized by the
 Employer; however, it is now properly certified under the Canada Labour
 Code. Bargaining has commenced for a renewal agreement, with dates
 set for the fall.

- On August 14-16, 2012 PSAC met with the University of Western Ontario to exchange proposals for DCL 00610. Negotiations will continue to proceed with dates set for the fall.
- The Ontario Labour Relations Board has issued a new certificate to PSAC to represent approximately ten (10) employees at the Hearst, Kapuskasing and Smooth Rock Falls Counseling Services in Moosonee on August 21, 2012.
- PSAC is currently negotiating with Queen's University in Kingston for a first collective agreement for DCL 901 - Post-Doctoral Fellows at the university.
- The employers for the First Nations Police Civilians and Officers employed at Anishinabek Police Service (APS) and Nishnawbe-Aski Police Service (NAPS) are challenging the jurisdiction of the Public Service Alliance of Canada union certifications under the Canada Labour Code. The Canada Industrial Relations Board has considered their jurisdictional objection and PSAC is now waiting on hearing dates.

Tentative Agreements

 A tentative agreement has been reached on July 26, 2012 for PSAC members at the Non-Public Fund – Kingston – Operational Category (UNDE Local 00681). A ratification vote has been scheduled for September 10, 2012.

Renewal Agreements

- On May 10, 2012 PSAC reached a tentative agreement with members working at Wequedong Lodge in Thunder Bay (DCL 002). The agreement was ratified on May 14, 2012.
- Akwesasne Mohawk Board of Education Teachers bargaining unit ratified their new collective agreement on May 24, 2012.
- UNE Local 00358 ratified their new collective agreement with Candu Energy on May 31, 2012.

Organizing

PSAC currently represents Teaching Assistants and Post Doctoral students at the University of Western Ontario, and would like to recognize their support and contributions in trying to extend the benefits of unionization to their brothers and sisters doing similar work. Unfortunately, on June 28, 2012 PSAC lost a union certification vote for 130 Graduate Student Assistants and Research Assistants at the University of Western Ontario.

Provincial By-elections on September 6th, 2012

In Ontario two by-elections have been scheduled, both for September 6, 2012 – Kitchener-Waterloo and Vaughan. Both by-elections are extremely important as they could mean a transformation of the current minority Liberal government to a majority. The Liberals were forced to work with the NDP to pass the Ontario budget, which gave the NDP the ability to negotiate higher taxes for wealthy Canadians, freeze corporate tax rates and provide a slight increase on welfare payments. Therefore, it is vital that the Liberals are kept at a minority government, forced to work with the NDP and that the Conservatives are highlighted for their anti-union, anti-working class platforms.

PSAC Ontario sent a letter to all our members in both ridings informing them to educate themselves on the issues and vote for a representative that would defend and enhance public services. Members were also called leading up to both by-elections to ensure they knew the candidates platforms and the overall parties' stances on public services. As we have recently seen with the Liberals threatening to interfere with collective bargaining for teachers through legislation; the Liberals have shown their similarity to the Conservative party. With a potential election in the relatively near future, each by-election serves to mobilize and educate our members on these issues.

Mobilization

Workforce Adjustment (WFA)

The Ontario region has and will continue to deliver WFA training through the regional offices and at worksites. The WFA training was designed to inform members of their rights under WFA and help guide members through the process. For this reporting period our region has continued to prioritize the delivery of WFA training to locals as requested. 23 WFA sessions have been delivered during this period in addition to the 37 sessions delivered since the beginning of this year, for a total of 60. Further WFA training has been scheduled for the fall to locals through lunch and learns at worksites and through the regional offices.

To support and mobilize members for Parks Canada bargaining, during the May long weekend (May 19-21, 2012), several parks were targeted for info pickets. Members leafleted the entrances of these parks as visitors entered. The parks targeted include; Fort Malden, Point Pelee, Fort Wellington, Georgian Bay Islands National Park, and Honey Harbour.

National Public Service Week – June 11-15, 2012

Kingston – On June 10, 2012 the PSAC Area Council, in conjunction with locals and Components in the area held a National Public Service Week event at the Royal Canadian Legion branch 560 from noon till 2pm. Members organized a blues band, bouncy castle, face painting, colouring station and games for children.

Toronto – On June 15, 2012, PSAC regional staff, the Regional Executive Vice-President for Ontario and PSAC's National President, Robyn Benson, held a rally at noon in front of 25-55 St. Clair in Toronto. This location was selected since it houses many federal government departments. The rally was a tremendous success and received media attention.

Sudbury – On June 12, 2012, UTE 00042 served more than 300 slices of pizza at a mock funeral for public services in front of the Tax Centre in Sudbury.

Many locals around the province held their own National Public Service Week events. Coordinating barbeques, baking cakes with political messaging, and generally getting together to boycott their employer events, demonstrating their dissatisfaction with cuts to public services.

To support ongoing Frontier Border bargaining, PSAC held a picket at the head office at Pearson Airport on June 22, 2012 at noon. Members from the local, Component and PSAC's Ontario Regional Council stood together to demand a fair contract.

In June, 2012, PSAC Ontario officially launched our new regional webpage: http://ontario.psac.com. The website provides a much more user-friendly interface, increasing visual appeal and a greater integration of our online and social media applications. Member feedback has been extremely positive and the site traffic continues to increase.

We Are All Affected Campaign

On June 12, 2012 the Kingston Area Council, with support from UCTE and PSAC Ontario, began a campaign to protect Ontario's Historic Canal Systems. With the slashing of Parks Canada's budget, Ontario's historic canals, such as the Rideau and Trent-Severn Waterway, were under threat of shorter seasons and operating hours. With many local communities depending on these tourist attractions for their economies, and with PSAC members under threat of losing their jobs, an online Twitter campaign and petition to the House of Commons to stop these cuts was created. Various posters and materials were also developed to educate the public on the importance of these canal systems and how cuts were placing local communities in jeopardy. The campaign has garnered media attention, political and community support and thousands of signatures to stop the cuts to Canals.

July 1, 2012 – PSAC entered a float and members marched in the Toronto Pride Parade. The PSAC float was beautifully decorated and highlighted how public services are vital to ensuring equality. As the largest Pride Parade in the country, and one of the largest in the world, this event was vital for PSAC in publicizing the cuts to public services and demonstrating our continued commitment to

human rights by standing with the Lesbian, Gay, Bisexual and Trans communities.

July 6, 2012 the PSAC Kingston Regional Office held a Labour Meet and Greet from 12pm – 2pm. The NDP Labour and Community Safety and Correctional Services Critic, Taras Natyshak was invited to speak to members on how the opposition is fighting the cuts to public services.

July 12-15, 2012 – Kingston Buskers Rendezvous

The Kingston Area Council, Ontario Council, USGE and Locals in the Kingston area had a booth at the Buskers Rendezvous festival. Members spoke to the public about the cuts to public services and explained how "We are all affected". People were asked to sign affected letters to Harper and also sign petitions for the Save Our #HistoricCanals campaign as well as the Ontario Healthcare Coalition campaigns.

July 19-21, 2012 - Kitchener Ribfest and Craft Beer Show
Members of the PSAC Kitchener-Waterloo Area Council, armed with Public
Services Are Cool fans, attended the Downtown Kitchener Ribfest and Craft Beer
Show, to remind Canadians that recent cuts to public services affect us all.
Members handed out "Public Services are Your Services" wristbands, offered
Protect Public Services fans to cool down attendees and handed out "Stephen
Harper Hates Me" buttons.

August 23-26, 2012 – Kingston Blues Festival

The PSAC Kingston Area Council had a tent and tables at the Blues Festival in Kingston, as part of PSAC's We Are ALL Affected summer campaign. Members of the Kingston Area Council, USGE, UCTE, UNDE and DCL 818 and 901, engaged with thousands of Blues fans and collected hundreds of signatures for the Save Our # Historic Canals campaign as well as the Ontario Healthcare Coalition campaigns.

Education

July 27-29, 2012 PSAC Ontario held a Young Workers Summit in the Toronto Regional Office. Young PSAC activists were selected from around the province to engage with each other on issues facing young workers and how to better engage with their union. The Summit also provided the building blocks to begin outreaching to young workers within our region, with the goal of creating Young Workers Committees.

Labour Movement/ Solidarity

The Regional Executive Vice-President for Ontario, together with a group of members and staff from the Toronto Regional office, lent their support against the recently announced 15% wage cuts for Foreign Temporary Workers at a loud and lively protest in front of Conservative MP Joe Oliver's office on May 24, 2012.

PSAC Ontario made a financial contribution in support of the *Justicia for Migrant Workers* in the amount of \$500 for a vigil on July 22, 2012, to commemorate the deaths of the 11 migrant workers killed in the Hampstead accident. Members were encouraged to participate in the vigil, which highlighted the plight of unsafe working conditions for migrant workers in Canada.

Equity and Human Rights

On June 2, 2012 PSAC Ontario established its first Pride Committee in Toronto. Elections for committee positions were successfully held during the first meeting. This is the third PSAC Pride Committee in the entire country and members are ecstatic over this historic equity initiative.

June 16, 2012 – PSAC Ontario became a Gold sponsor of the Kingston Pride Parade for the amount of \$500. Members marched for equality for the Lesbian, Gay, Bisexual and Trans communities and handed out "We are All Affected" materials to explain how public services are being eroded.

Item 5. PSAC Ontario Regional Office – Updates

(Christopher Wilson, PSAC Ontario Regional Coordinator)

Christopher Wilson presented his report.

The Ontario Region remains a very active region supported by a dynamic collective of staff.

Staffing

A competition has been started for a permanent Regional Representative in the Sudbury Regional Office. There is a bilingual imperative requirement on the position. The position arises as a result of Debbie St-Germain transferring into Jawara Gairey's position following his successful candidacy for the Regional Negotiator position. While the interview process continues Norbert Wenzel will continue as acting Regional Representative.

After twenty two years of dedicated service to PSAC as a Regional Representative in the Ontario Region and Acting Coordinator in the North and following years of activism within UNDE prior to working for PSAC, Tom Hamilton recently announced his retirement effective the end of November. Tom has an open invitation to our next Regional Staff Conference which will be the next time that staff within the Region are all together and can recognize his contribution to the Region along with his friendships within the Region.

PSAC received a cheque in the amount of \$2780 from the Canada Summer Jobs program as a subsidy for the costs of employing a student (Matthew Couto) during the summer of 2012. This revenue will be credited to the organizing program from which Matthew was paid. This is the first successful application that PSAC (Ontario) has filed for a summer student through the Canada Summer Jobs program. The objective next year will be to build upon this experience and submit new application(s) in 2013 for additional student(s).

Matthew made a substantial contribution to our Region through his involvement in the RA campaign at Western, We Are Affected campaign mobilization efforts and workplace mapping research.

Sandra Goodick was the successful candidate for one of two Career Enhancement Positions across the country. Sandra will be working in the Thunder Bay Regional Office during her one (1) year CEP position. The CEP program is negotiated under the CULE collective agreement as a skills development initiative for administrative staff within PSAC.

I am pleased to announce that Jennifer Kovacs was the successful candidate in the competition to backfill Sandra Goodick for a 1 year term commencing October 25th, 2012. Jennifer previously completed a term assignment working as an Administrative Assistant in the Thunder Bay Regional Office so she has direct experience in the position. Jennifer is a member of the Agriculture Component working in Thunder Bay and is active within the Union with a passion for health & safety activism.

Nancy Richter was the successful candidate to backfill Lynn Eaton as an Administrative Assistant in the London Regional Office effective August 27th to November 27th, 2012. Nancy is an active PSAC member who works as an Administrative Assistant for Agriculture Canada and previously completed an acting assignment as a PSAC Regional Representative in the London Regional Office during the month of June 2006.

Beth Bennett was the successful candidate to backfill for Denise Morrison as term secretary in the Toronto Regional Office until November 30th, 2012. Beth is a PSAC member working for Service Canada.

A competition has been started for a term secretary within the Toronto Regional Office to backfill Marion Kirin for a two month term. The competition has closed and the successful candidate will be announced within the next week.

There have been no other staffing changes since my last Report to Regional Council

Unionware

The Membership, Events and Cases modules of Unionware are now live. The membership module is designed to replace our pre-existing MOCHA membership system and provide a state of the art centralized database to store membership information. The Events module is designed to track membership participants in various PSAC courses. The Cases module is designed to track WSIB cases, grievances and other related cases. All staff within the Region now have access rights that reflect their usage of the system. Training has been delivered within the Thunder Bay Regional Office and Toronto Regional Office with ongoing training planned for London, Sudbury and Kingston.

Renovations

The renovations within the Toronto Regional Office are nearly completed with a fully integrated design to replace the prior patchwork layout of the office. Feedback was provided from the MDAC committee which has been forwarded to PSAC Holdings with a view to ensuring that the office is accessible to all members. Further modifications that have been requested include lowering the outside counter in the membership kitchen in the large boardroom and lowering the transaction windows for the two secretarial offices in the main lobby. New office furniture has been ordered for the two secretarial offices to ensure a new look in the reception area and a boardroom table has been ordered for the small boardroom to make that room accessible for membership meetings.

The Sudbury Regional Office has now been relocated to the new location at 754 Falconbridge (289 Cedar Street). The new office has easily accessible parking, signage that is visible from the street, a large boardroom with a skylight, offices for two Regional Representatives, an Administrative Assistant office all with natural lighting as well as a leave without pay office for members working on campaigns. The new office represents a significant improvement upon the previous office space at the Rainbow Mall.

I am available to respond to any questions arising from this report.

Item 6. Ontario Council Committees Reports

The REVP expressed her pride with each Council member for taking a lead role in Ontario regarding the cutbacks. For example PSAC Ontario collected 8,000 signatures in 2 months from local residents to protect Historic Canals by advocating against the cuts to Parks Canada. Through activism we will see major changes in our communities and government.

Equity and Human Rights Committee Report (Appendix "A"):

Sister Karen Church presented on behalf of the Equity and Human Rights Committee.

Sister Church put forward a motion to hold an education session for Council at the next Council meeting on Transgender issues and to invite Sister Nicole Nausbaum to be the guest speaker. The estimated cost of this proposal is up to \$700.00. Given the cuts from both Federal and Provincial governments, members of the transgender community will be faced with further barriers. The committee would ask that pending the motion be passed, that the Toronto Regional Office promote this education activity to the membership at large.

Brother Bob Black suggested that the funding request of \$700.00 for the motion can come from the special initiative budget line item.

Brother Brad Feraday made an amendment to the motion for the education session to be held before the June 2013 council meeting.

Education Committee Report (Appendix "B"):

Sister Debbie Willett presented on behalf of the Education Committee.

The Committee will be developing a brochure that will give members guidelines on how to achieve education goals. For example, a member wanting to be a local officer, the brochure will give them direction on the courses they would need to take to accomplish that goal.

Some of these courses were developed in other regions. Sister Shirley Riva Regional Education Officer to advise Regional Representatives on these new courses.

Geo-Base Courses delivered out of the Regional Offices will only be open to members that live in that particular region.

Action Item: What is the minimum class size number, because in some areas the courses are being canceled due to class size while it is ago in other areas.

Recommendation: The Committee recognizes that Directly Chartered Locals (DCL) do not have trained facilitators, therefore we will be holding two Alliance Facilitator training programs. One Alliance Facilitator training program for DCL members and another for Component members.

Finance Committee Report (Appendix "C"):

The Committee Chair, Brother Bob Black presented the Committee's report.

Brother Bob Black has worked tirelessly setting up the Simply Accounting software program and completing the Council's books. The Committee has worked out the roles and responsibilities of each member of the Committee, however, they have not yet completed a terms of reference for the Committee.

The Finance Committee has put forward five (5) recommendations to Council, as shown below:

Recommendations to Council:

1. If a member hasn't cashed a cheque within 5 months of the date of the cheque then the REVP's office will send a follow-up email and letter to the party who hasn't cashed it. If it hasn't been cashed one year after the date of the cheque then it will be cancelled.

The intent of the follow-up email and letter is to remind the member/individual that they have an outstanding cheque. The member/individual can still request a replacement cheque if one (1) year has elapsed.

Sister Vicky Pine made amendment to the recommendation; the email and letter should be sent out five (5) months from the date that the outstanding cheque was written.

2. For 2011 and 2012 we will have 3 members who are at arm's length from Council to do the random verification of entries. These members will be appointed.

The Chair of the committee clarifies the statement "arms length" means that it cannot be members from Council to review the finances.

Brother Bob Black attempted to make an amendment to the recommendation. The amendment strike out "These members will be from Region 5 to minimize the cost", from the recommendation.

Brother Réjean Amyotte stated the recommendation would be out of order with by-law 11 sub-section (1), because of the fiscal cost.

The interpretation made by the REVP of section 11 sub-section (1) was the recommendation was in addition to the by-law.

Health & Safety Committee Report (Appendix "D"):

The report was presented by the Committee Chair, Brother Réjean Amyotte.

The Committee Chair informed Council that WSIB has changed the process of appealing a decision. The new process would make a submission to the board and the board could make a written decision from the submission.

It can take up to 200 hours to write a WSIB appeal. An honorarium is paid to members for the hours they work on an appeal. Members can be paid up to \$200.

The Region has a fair amount of WSIB backlog claims. We would need to review these claims to see how many members to date have completed the Occupational Disabilities Response Team (ODRT) course and if we would be able to solicit help from them to help clear the Region's backlog.

Brother Chris Wilson stated that he has asked Sister Angela Fairweather to write up a recommendation for a policy in regards to reducing the backlog of claims that he could present to the REVP or Health & Safety Committee.

Action Item: The REVP will look into where the \$200 honorarium funding comes from.

Item 8. Ontario Council Members Reports (Appendix "F"):

The Chair gave Christine Collins, National President of the Union of Canadian Transportation Employees (UCTE) a warm welcome and a thank you for all the work that was done in conjunction with PSAC Ontario Region in campaigning to save the Historic Canals.

Brother Ralf Bucherer expressed his gratitude to Brother Lino Vieira for creating the press releases and speaking notes.

Action Item: Brother Brad Feraday asked the REVP to put forward at the next NBoD meeting the Halloween theme of the grim reapper, as our next theme for Political Action.

Item 9. <u>Fight-back Plan- We are all affected Campaign</u> Summer events

The Chair cautioned Council members around the table in regards to the comments as to why leaders are not present at actions. There have been many changes within the Region in regards to work scheduling and changes WFA brought on members. Brother Lino Vieira stated there were multiple campaign priorities and goals, since Ontario has a lot of key political ridings.

The Ontario Federation of Labour (OFL) brought together Political and Communication officers from different Unions. The OFL website "We Are Ontario", uses the content provided by affiliates and the website is managed by the OFL. PSAC can put suggestions forward.

Action Item: Brother Brad Feraday would like Brother Lino Vieira to put forward the suggestion of making the "We Are Ontario" website more dynamic to the OFL.

The PSAC Ontario Region held its Fall School in the month of September. The school had a food drive where members who attended the school donated canned items. All the items that were collected were given to the London food bank, also PSAC Ontario Regional Council donated \$500. Food banks are becoming quite vocal; with the drastic cuts in Public Services they have seen an increase in the number of people accessing the service.

Labour Day

The Labour Day t-shirts were very popular this year. Members really liked the colour and the slogans that were written on the back.

The Toronto Labour Day parade was a real success. By planning ahead for the event, there was a greater turn-out this year. At the Toronto Labour Day event, PSAC won an award for "Most Spirited Participation".

The newly elected National President, Sister Robyn Benson and the REVP of Ontario, Sharon DeSousa participated with the Hamilton and Niagara Area Council members at the Hamilton Labour Day celebration. PSAC had a great turn out.

September 15, 2012

The REVP stated the NBoD had a debrief concerning September 15th Day of Action. The consensus was that we need to maximize our

communication efforts with the members. Sending emails sometimes does not get the message out, therefore we should return to plantgating which gives a visual effect and a face to face meeting with members. As a Region, we need to recognize the contributions of staff representatives and to do a further analysis to make sure the action was a success.

Sister Melanee Jessup stated that the timing of the Action contributed to the poor turn-out for the event because most Labour Councils did not meet over the summer break and planning an event right after the summer holidays is difficult. However, the Kitchener/Waterloo area

was able to network and made some really great contacts with affiliates that attended the event.

Item 10. Collective Bargaining

Brother Réjean Amyotte provided an update on the Statistical Survey Operations (SSO) Regional Officers and Field Interviewers negotiations. The bargaining team is still trying to work with the employer and the employer is refusing to bargain. They are willing to give ongoing work to employees but they will not put it in writing. We have since filed for an impasse. On November 30 we will be picketing at all the SSO offices to mark our anniversary of being without a collective agreement.

Sister Vicki Pine stated that the Anishinabek Police Service Board – Civilians signed their collective agreement in late October. Due to the on going jurisdictional challenge the employer does not want to recognize the collective agreement.

"We have lost six (6) fulltime Civilian positions by turning them into part time positions. The employer is intimidating officers forcing them to quit and to take severance packages. But we are not giving up and we are pushing back," stated Sister Pine.

Sister Karen Church who is a member of the bargaining team for the FB group, stated they have been without a contract for over a year and a half. An impasse was filed in April of this year and they had to

go through a process before they can do a strike vote. Our negotiator Brother Morgan has filed a complaint with the Labour Board.

It has been a struggle with this employer. With the shooting of the officer in B.C the bargaining team is going as fast as they can, looking at different ways that officers can work the primary lines. One suggestion is bullet proof booths. We head back to the table on December 10-12.

Item 11. Communications- Ontario Council Youtube Challenge

The Ontario Council Youtube Challenge has come to a close. The winners were chosen and invited to attend the Saturday session of the Ontario Council meeting. Brother Réjean Amyotte paid recognition to Sister Mary Jeyananthan for bringing this initiative to Ontario Council.

The two (2) winning teams for the My Community ~ My Future ~ My Public Services PSAC Ontario Video Competition were:

- Team 1 Derrick Glende (CEIU Local 620)
- Team 2 Ronda Evans, Tim Eddis and Rita Lemick (NHU Local 00009)

These PSAC members are helping to raise awareness of the negative impacts cuts to public services have on their communities. Both videos can be seen on the PSAC Ontario webpage: http://ontario.psac.com/content-type/video

The REVP presented the winners with their prizes, Blackberry playbooks and Certificates of Appreciation.

Ontario Council Newsletter

Brother Lino Vieira made a suggestion to split the newsletter into two releases. The first release would go out the 2nd week of November and final release would go out at the end of November.

Brother Christo Aivalis advised Council members that he will from time to time approach them for help with pieces for the newsletter.

Preserving Labour History

Brother Christo Aivalis stated that PSAC does not have an in-depth account of its Labour history. PSAC's history will not be told unless we give it the tools for our history to be told. We can start off by saving buttons and flyers from rallies because these are the kind of items Universities are interested in.

Item 12. Workforce Adjustment

The REVP stated that every department is having a hard time with Workforce Adjustment (WFA). PSAC has been getting a lot of complaints about the WFA process and the employer is not providing the required information. PSAC has an updated master list that provides affected numbers by city, but it does not tell you the job that is affected

Item 13. PSAC Ontario Regional Triennial Convention

Sister Cleo Reid did a preliminary review of all the hotels in the City of Hamilton by connecting with the Tourism Board of Hamilton. The only space that could house our convention is the Copps Coliseum and hotel space would be Sheraton hotel.

The Copps Coliseum meeting rooms would cost \$20,000 more than if the Convention was held at a hotel. Sister Reid has set up site visits for four (4) hotels in Toronto for the 3rd week of November. Once those are completed, the REVP will be conducting a conference call with Ontario Council to make a decision on venue.

Sister Laura St-Jean made a motion that we focus on holding the Regional Triennial Convention in Toronto.

Sister Cleo Reid reported back that the cost is cheaper in April than it would be later in the year. It would be more fiscally responsible to hold the Regional Triennial Convention during that period.

Item 14. Young Worker Summit 2012

Brother Christo Aivalis acted as Chair at the summit. There were 18 members that took part at the summit which came in under budget mainly because university space was used.

A lot of young workers believe their issues are being ignored and there has to be a way to bridge the intergenerational gap.

Sister Sandy Bello completed a Young Worker survey for Canadian Labour College, which revealed many of the findings reported by Christo.

Action Item: The REVP recommended that the Human Rights & Equity group look into adding Anti-Oppression training, not just tolerance but challenging racism, sexism, and other forms of oppression as an agenda item to one of the upcoming Ontario Council Meeting.

Item 15. <u>PSAC Ontario 2012 Directly Chartered Locals</u> Conference

Sister Vicki Pine stated the Directly Chartered Locals (DCL) Conference was a great success, with 100% participation from all attendees. PSAC Ontario has shown strong support for the DCL groups. The materials were designed for the DCL group and this showed growth since the last DCL School held last summer.

Item 16. Raise the Rates Campaign Presentation by John Clarke

The Ontario Coalition Against Poverty (OCAP), along with a range of unions and community allies, are working to restore the adequacy of social assistance benefits to the levels that existed before the Harris Tories drove them down. Mike Harris cut social assistance rates by 21.6%.

In Ontario, unions are under attack and one worker in six, works at or close to the minimum wage. This growth of the low wage sector has

been possible because of the weakening of Employment Insurance and social assistance systems.

For several years, starting in 2005, OCAP focused its efforts around social assistance adequacy as a major drive to access the Special Diet benefit. The Special Diet was a poorly accessed benefit but through promotion of it, people began to utilize the benefit. With the increase in utilization of the benefit, the McGuinty Government, despite its claim to be a 'poverty reduction' administration, responded by restricting access to the benefit.

In the last Provincial budget the McGuinty Government decided to eliminate the Community Start Up and Maintenance Benefit (CSUMB) on January 2013. This vital benefit provides a very modest maximum payment of \$799 to single people and \$1,500 to families. They may apply for this in order to maintain or obtain housing. This benefit can be accessed once every two years, and is accessed by 16,000 people a month in Ontario who are in extremely serious and vulnerable situations. Its elimination will put people on the streets who might otherwise had been housed.

The Raise the Rates Campaign has dozens of organizations endorsing it, including the Ontario Federation of Labour. CUPE Ontario has put very significant resources into the campaign and has helped to organize town hall meetings in a range of Ontario communities. Support has also come in from the Canadian Union of Postal Workers, the Ontario Nurses Association and, now, the Ontario Region of PSAC. OCAP must respond to the attack by creating a movement that defends past gains and leaves no one behind.

The REVP states that Lino Vieira will forward speaking notes to Ontario Council once he gets the information from Brother Clarke. This will allow Council members to engage in conversations with membership at large and promote the Raise the Rates campaign.

Sister Laura Eastcott brought a motion forward that Ontario Council fully endorse the Raise the Rate Campaign.

Item 17. <u>Bill 115 Putting Students First Act Presentation by</u> Irwin Nanda

The Ontario Liberal government has launched an all out attack against workers to impose an austerity agenda that penalizes the poor and working class. The creation and implementation of Bill 115, deceitfully titled "Putting Students First Act", is an affront to the notion of improving our education system. It effectively ends any meaningful dialogue between teachers, education workers and support staff with their employer, the school boards.

Bill 115 gives the government unprecedented powers over school board negotiations with no accountability through legislative debate.

Majors Points of the bill;

- Singles out one sector education for wage restraint.
- By-passes the legal bargaining regime by imposing contract provisions.
- Suspends the normal, legal framework for negotiating contacts with school boards.
- Introduces extraordinary legislative measures to prevent legal challenges to the bill.
- Sets a dangerous precedent for other unionized employees in particular and democratic principles in general.
- Gives Cabinet rather than the Legislature the right to restrict strikes and lockouts.
- Gives Cabinet the power to extend the provisions of the bill beyond two years without having the issue debated in the Legislature.

- Gives the Minister of Education unlimited and unprecedented powers to approve or change any contract negotiated between school boards and the affected unions.
- Gives the Minister of Education authority over collective agreements that are governed by labour legislation under the jurisdiction of the Ministry of Labour.
- Bill 115 is part of an austerity agenda that cuts taxes for large corporations, banks and the wealthy while cutting public services for everyone else.
- Bill 115 is only the first step. The government has announced it will be seeking concessions from other public sector workers.

The OFL is drafting a 10 point plan and will be approaching MP's and all Labour Councils, including the Northern regions asking them for support.

The REVP stated in a show of Solidarity, Brother Lino Vieira will be writing a letter to the editor which he will send throughout the region for wide distribution and use.

Item 18. <u>Bill C-377 An Act to Amend the Income Tax Act Presentation by Federico Carvajal</u>

On May 12, 2011, Russ Hiebert, Conservative MP for South Surrey, White Rock and Cloverdale, introduced Bill C-377 into the House of Commons. The Bill is called An Act to Amend the Income Tax Act (Labour Organizations) and if passed would make it mandatory for all Labour Organizations to make detailed annual financial filings covering salaries, revenues, and expenses. The information would be posted on the Canada Revenue Agency (CRA) website, for anyone to read.

Individual transactions above \$5,000 would need to identify the payee, payer, the purpose and description of the transaction. For example, should a local rent an office space, over a year that would amount to over \$5000. The information that would be posted on the CRA website would include the name of the property owner, address and cost. Locals would be forced to hire accountants to keep track of all the Bill's reporting requirements to ensure that they are not found

in contravention of the act, the fine for not complying with the act is a \$1000/per day.

PSAC already produces audited financial statements given to our members at Conventions; to ensure transparency and accountability to our membership. Members are entitled to this information, however, the Employer should not be.

Imagine at the next round of bargaining, the Employer knows exactly how much you have in your strike fund or the total amount you can afford in legal fees. This is what this Bill is really about, taking away a union's ability to bargain fairly. This is an attempt to weaken our financial base to cripple the Labour Movement's ability to function as a counterweight to corporate interests and Conservative ideologies. Final vote will be around November 20, 2012.

The REVP stated we need to put pressure on our MP's, speak to people that we know and get Labour Councils on board. We need every member to take a stand against this Bill to ensure that it does not pass.

Item 19. New Business

Motion Presentated by Brother Réjean Amyotte

The annual review of the finances and expenditures of the PSAC Ontario Regional Council shall be reviewed by a person holding a recognized professional accounting designation.

It is further moved that an amount not to exceed one thousand five hundred dollars (\$1500.00) shall be allocated for the purpose of conducting this review.

For information purposes:PSAC Ontario By-Laws

Section 11

Finance and Collection of Affiliation Fees

Sub-Section (1)

The PSAC Ontario Council shall be funded from the budget allocated by PSAC Ontario and from any affiliation fees that are determined by PSAC Ontario Triennial Convention.

Sub-Section (2)

The fiscal year of the PSAC Ontario Council shall be from January 1 to December 31. A Committee of three shall be elected by the Council to perform an annual review of Council finances and expenditures. Such review shall be audited by a Public Accountant. The report of the Review Committee with its recommendations shall be presented to the first meeting of the year of the PSAC Ontario Council. A financial report shall be produced at the PSAC Ontario Triennial Convention.

Moved by Brother Réjean Amyotte

Seconded by Sister Laura Eastcott

Brother Ralf Bucherer made an amendment to the motion to replace the word reviewed with audited. The REVP stated the intent of the motion is to have the books reviewed. When the term audited is used it requires an in-depth accounting of the finances; the amendment would change the intent of the motion. Therefore the amendment is ruled out of order.

The REVP states that in the future all motions must be sent into the REVP office and will be sent out with the rest of the meeting package to Council.

The past National President Brother John Gordon made a ruling four (4) years ago and he stated that it is not required to have council books audited by an Accountant with a designation. The National Constitution can only be interpreted by the National President.

The REVP stated that at every year end, Council and the REVP's office must submit their bank statements to the National President for review.

Brother Bob Black who has been a respected member on Council stated that in past practice three (3) members of Council and one (1) outside member from Canada Revenue Agency would review the books. Also with the new accounting software that we are now using Simply Accounting there is very little room for errors.
