## Item 1. Adoption of Agenda

# **Treasury Board Area Coordinators Network**

Brother Chris Wilson reported back on the structure of Area Coordinators within the Ontario Region, as follows:

**Toronto** – There is a well-established Area Coordinator structure with 39 members on the list. The group is pushing ahead with a positive campaign and meets regularly on a monthly basis.

**London** – There is an Area Coordinator network in place that convenes regularly via conference calls.

**Thunder Bay** – The mobilization structure is based largely upon the local structure. Judith supplements the local structure through mobilization tours within the service area.

**Kingston** – Treasury Board mobilization structure is in place and is being built on an ongoing basis. The service area has been engaged in various mobilization activities.

**Sudbury** – The degree of engagement varies across the service area. Mobilization is being done from on a Local level.

## Bargaining Team Support

The Chair stated that a memo was sent to all Components Presidents requesting them to have signed Component flags sent to the Bargaining teams showing solidarity.

The REVP's office has designed a banner that will be used as a backdrop by the Bargaining teams. Area Coordinators will be collecting signatures from members across the Ontario Region. Once completed the banners will be sent to the different Bargaining teams.

# Item 4. Regional Executive Vice-President Report

The REVP acknowledge Sister Lauren Baert who gave a presentation to the National Board of Directors (NBoD) in regards to the hurdles and struggles of young workers.

Also, the REVP recognized the tremendous work that Area Coordinates have done throughout the Ontario Region.

The following is the REVP's report to the PSAC National Board of Directors for the period following our last PSAC National Board of Directors Meeting.

## **Collective Bargaining**

## Ongoing Bargaining

- Treaty Three Police officers (DCL 410) met with the Employer in December to negotiate a renewal agreement. On December 18, 2014, talks broke off and the team has decided to apply for arbitration.
- Nishnawbe-Aski Police Service (NAPS) officers (DCL 401) are heading to mediation on February 24-25, 2015. Interest arbitration has also been scheduled for June 2015.
- Nishnawbe-Aski Police Service civilians (DCL 400) are continuing to meet with the Employer, with dates not yet finalized for 2015.
- Anishinabek Police Service officers (APS) (DCL 426) has been granted an extension for the conciliation timeline, which will expire on January 30, 2015. The team will then look to apply for conciliation.
- Anishinabek Police Service civilians (DCL 425) are in conciliation, with dates expected in early 2015.
- University of Ontario Institute of Technology sessional instructors (DCL 555) met in November 2014. The bargaining team met on January 15 and will meet on January 23<sup>rd</sup>, 2015 to continue negotiations.

# Renewal Agreements

- On October 6, 2014, UCTE Local 50505 members who work at Thunder Bay Airport ratified their new collective agreement.
- On January 20, 2015, Wequedong Lodge (DCL 0002) members ratified their new collective agreement.

## First Agreement

 On January 19, 2015 Weeneebayko Area Health Authority (WAHA) members (DCL 00603) achieved a first collective agreement.

## **Organizing**

Graduate-Student Research Assistants at Queen's University PSAC filed a certification application on April 23rd, 2014 to represent 1600 Graduate-Student Research Assistants at Queen's University. The vote was conducted on April 30, 2014, however, the results are sealed due to the employer contesting certain ballots cast. The process is before the Labour Board currently.

#### **Operational Managers at Ontario Corrections**

PSAC Ontario has launched a campaign to organize 600 Operational Managers employed by Ontario's Correctional Services. Ontario's Correctional Service establishes, maintains, operates and monitors correctional institutions and probation and parole offices. The Union of Solicitor General Employees (USGE), a Component of the PSAC, has expressed their support for this organizing campaign. PSAC filed a certification application to request a Union vote and the Ontario Labour Relations Board (OLRB) ordered a vote for the week of April 16th till April 19th, 2013. All ballots have been segregated and the count postponed until the Employer challenge with respect to managerial exclusion is dealt with. The first hearing date took place on October 9, 2013, with hearings continuing in 2015.

# **Toronto Municipal Election**

On October 27, 2014, municipal elections were held across Ontario. As part of PSAC's We Are All Affected campaign, the protection and promotion of public services is our union's priority for all levels of government. In Toronto the stakes were especially high, as Canada's economic centre, PSAC was involved in challenging the austerity agenda.

An email from the REVP to all the Greater Toronto Area Local Presidents, Area Council and Committee Chairs on the election's importance with key information was sent out. Members were asked to visit the Toronto and York District Labour Council's www.ourcitymatters.ca webpage, which ranked candidates based on their commitment to workers' rights and public services.

A mail-out was also sent, with a letter from the REVP and a candidate report card from the Toronto and York District Labour Council (TYLC), to members in five priority ridings. The ridings were selected based on the TYLC's recommendations, and are as follows:

- Ward 17 Davenport Alejandra Bravo was not successful
- Ward 9 York Centre Maria Augimer was elected
- Ward 30 Toronto Danforth Paula Fletcher was elected
- Ward 12 York South Weston Lekan Olawoye was not successful
- Ward 29 Toronto Danforth Mary Fragedakis was elected

Members from the PSAC Greater Toronto Area Council held a phone bank to contact members in the above priority ridings, providing information on the election and the importance of voting. As noted above, three of the candidates endorsed by the TYLC were successful out of the five targeted.

## **Federal By-elections**

A federal by-election was called for the riding of Whitby—Oshawa on November 17, 2014. The seat became vacant after the passing of Conservative MP Jim Flaherty. The riding was a Conservative stronghold and this trend continued with the Conservative candidate Pat Perkins winning 49% of the vote.

However, Liberal newcomer Celina Caesar-Chavannes, tripled the Liberal share of the vote from 2011 by winning 40% support, albeit on a low voter turnout of 31.8%. The NDP candidate Trish McAuliffe saw her share of the vote shrink from 22.3% in 2011, when she came in second, to just 8% in this by-election.

# **Provincial By-election**

# **Sudbury by-election**

A by-election has been called for the riding of Sudbury for February 5, 2015. The by-election was called after New Democrat MPP Joe

Cimino, abruptly resigned for family reasons after five months on the job. In a further twist to this by-election, federal NDP MP Glenn Thibeault resigned his seat to run for the Ontario Liberals in this by-election.

Currently the candidates are as follows:

- Ontario Liberal Party Glen Thibeault
- Ontario PC Party Paula Peroni
- Ontario NDP Suzanne Shawbonquit
- Ontario Green Party David Robinson

#### **Mobilization**

## Treasury Board Mobilization Meetings

Mobilization meetings continue to take place across Ontario. Area Coordinators have been identified, received training and continue to meet or conference call regularly in each of the Regional Office areas. The communications network has been established and is being strengthened with monthly actions.

## October 30th, 2014 - Day of Action

The Treasury Board National Strike Strategy Committee mandated a Day of Action at strategic locations across the country for information pickets on October 30<sup>th</sup>. This action was meant to send a strong message to the Employer that our members stand united in support of their bargaining teams and stand in opposition to concessions, including attacks on members' sick leave.

In Ontario two strategic locations were selected based on recommendations from the Area Coordinators. The information pickets were set for noon, to coincide with members' lunch breaks, to ensure greatest participation. The sites selected were:

- The Arthur Meghen building in Toronto at 25-55 St. Clair Avenue.
- The Judy Lamarshe building in Chatham at 65 William Street South.

Members handed out business cards which had been printed by PSAC Communications, held picket signs and gave out stickers. The Toronto event had roughly 40 members participate throughout the information picket. The information picket in Chatham had approximately 75 members participate, as well as a few retirees and UNIFOR support from the Chatham District Labour Council. The event received media attention from the Chatham Daily News and Blackburn News.

# Actions on the 19<sup>th</sup> of every month

All Locals across Ontario are being asked to come up with creative actions to show their solidarity on the 19th of each month, in anticipation of the Federal election originally set for Oct. 19, 2015.

Locals have come up with terrific ways of displaying their solidarity and photos have been shared on the PSAC Ontario Facebook page for members to comment and share. Locals have worn wrist bands, stickers, Band-Aids, solid colours and union swag all to show their support. A video from the REVP was posted on our Youtube channel and social media to garner further support from Locals to get involved. PSAC Ontario Council also released a short video just before the January 19, 2015 action to increase visibility and encourage more members to participate.

# We Are All Affected Campaign

## **Veterans Affairs Canada Campaign**

On January 5, 2014, Harper announced that MP Julian Fantino would be replaced as the Minister of Veterans Affairs by MP Erin O'Toole. Fantino served in the position for 18 months, but with a string of controversies surrounding his treatment of veterans and their concerns, he was demoted back to a junior minister.

With O'Toole stepping into the position, PSAC is once again calling for the opening of the Veterans Affairs offices that were closed down in 2014. Despite Minister O'Toole being a veteran himself, it seems his appointment will garner little progress from his predecessor in bettering the lives of veterans.

#### One-on-One Campaign

Our region continues to focus our one on one campaign through messaging around the importance of solidarity especially in terms of bargaining. Highlighting our wins in our collective agreements and the threat to these achievements has helped connect members with the importance of this campaign. We will continue to sign pledge cards and encourage member to member conversations, as bargaining remains a key priority for our membership.

## **Labour Movement/ Solidarity**

#### **Labour Day**

Labour Day participation from PSAC members in Ontario continues to grow. Members took part in events in: Kirkland Lake, Hamilton, Toronto, Barrie, London, Brampton, North Bay, Sudbury, Thunder Bay, Windsor, and Kingston. PSAC Ontario Council selected orange PSAC Ontario Labour Day shirts for members to wear at these Labour Day events, with the following three slogans written on the back:

- Solidarity is Power, Stand Together
- Unite Fight WIN!
- Stand Proud! Shout Loud!

#### Western Fair

PSAC London Area Council shared a booth with the London District Labour Council at the Western Fair in London on September 11 and 12, 2014. Materials on the impacts of public service cuts was handed out to the public. Members were able to discuss their experiences with the public on how programs are being impacted by budget cuts and what that means for Canadians.

## Save Canada Post Rally

A rally was held outside the constituency office of Conservative MP and Finance Minister Joe Oliver on September 20, 2014. The rally was meant to draw public support and garner media attention at the ending of door to door delivery service by Canada Post. The rally was endorsed by the: Canadian Labour Congress, Ontario Federation of Labour, Toronto and York Region Labour Council, Canadian Union of Postal Workers, CUPE-Ontario, PSAC-Ontario, OPSEU, Unifor,

United Steelworkers-Toronto, Ontario Coalition Against Poverty, Friendly Spike Theatre, Queer Ontario, Coalition of Black Trade Unionists, Peel District Labour Council, York Region Catholic Teachers, NDP Socialist Caucus, Toronto-Danforth NDP, C.P.C., I.S., and Socialist Action / Ligue pour l'Action socialiste.

#### **Council of Canadians Annual Conference**

Council of Canadians' annual conference *Forging Solidarity* took place in Hamilton on October 3-5, 2014. Bob Black, Alternate REVP for Ontario and Debbie Willet, Area Council representative on Ontario Council attended the conference to voice PSAC's priorities at the Conference.

#### **USW Local 2010 - Pay Equity Rally**

On October 2, 2014, USW Local 2010 held a lunchtime pizza rally seeking support from other unions and Locals on the Queen's University campus in Kingston. PSAC staff and Local 00901 Queen's Teaching Assistants and Postdoctoral members attended the rally to show PSAC's solidarity.

Toronto and York Region Labour Council Labour Day Award On October 2, 2014, PSAC Greater Toronto Area Council members received an award from the Toronto and York Region Labour Council for Best Decorated Vehicle for this year's Labour Day Parade.

# **Clothing Drive**

On November 20, 2014, the Kingston Area Council delivered several bags of clothing collected from members over previous weeks for a clothing drive in support of St. Vincent de Paul. The clothing drive has become a yearly event to improve the lives of the most vulnerable in the Kingston community.

#### **Hamilton Food Share**

On December 19, 2014 – Bob Black, Alternate REVP for Ontario, presented a cheque for \$700 to Rachel O'Reilly at the Hamilton Food Share organization. The donation was made by PSAC members during recent events for the PSAC Hamilton Area Council, Hamilton Regional Women's Committee and Hamilton Members with Disabilities Action Committee. Rachel was surprised and delighted to

receive the cheque on behalf of Hamilton Food Share, and thanked PSAC for their support during this holiday season.

#### **Food Bank Drive**

On December 19, 2014, CIU Local 19 held a canned food drive for the Inn of the Good Shepherd to show support for the PA and FB Bargaining Teams. With the holiday season about to begin this was a terrific initiative to give back to the community.

# Government of Canada Workplace Charitable Campaign (GCWCC)

To support the GCWCC, NHU Local 00009 raised \$7,758 for the 2014 calendar year. In spite of the cuts to this Local, members have shown they continue to be a hard-working, caring team of Canadians fighting for a better, healthier, and more equitable country. Of the total stated above, \$3,135 was raised by climbing the CN Tower for the United Way.

#### **Equity and Human Rights**

#### **Take Back the Night**

On October 2, 2014 in Barrie about 10 PSAC Sisters representing five different components took part in Take Back the Night. The event began with an Aboriginal welcome, then a feminist local band followed before speakers from various women's groups. The event ended with a march through the Barrie downtown core and cake to celebrate 15 years of Sisters taking back the night in the fight against male violence towards women.

## Sisters in Spirit Vigil

On October 4, 2014, members in Toronto participated in the 9th annual cross-Canada vigil by Sisters in Spirit (SIS), to raise awareness and demand action for missing and murdered First Nations, Inuit and Métis women and girls. Sharon DeSousa, REVP Ontario joined the vigil along with members to call for a public inquiry into the missing and murdered women.

# **Toronto Young Worker Committee**

On November 27, 2014, an open house was held in the PSAC Toronto Regional office to celebrate the inauguration of the first

PSAC Toronto Young Worker Committee. Sharon DeSousa, REVP opened the event, and Lauren Baert, PSAC Ontario Council Young Worker Representative gave closing remarks. Members discussed with each other the challenges of being a young worker in the federal public sector and the challenges to getting young workers engaged in their union.

## **Stephen Lewis Foundation Film Screening**

Through sponsorship from PSAC's Social Justice Fund, PSAC supported this new film screening from the Stephen Lewis Foundation on November 27, 2014 at the Bloor Hot Docs Cinema in Toronto. The film's screening was meant to honour World AIDS Day, as it features the courageous African grandmothers who gave powerful and emotional testimonies at the African Grandmothers Tribunal in Vancouver, BC in 2013. The documentary shines a light on the urgent need to provide better protection for the human rights of African grandmothers who, after watching their adult children die of AIDS, have become the primary caregivers for millions of orphaned grandchildren.

# National Day of Remembrance and Action on Violence against Women

Kingston - On December 6, 2014 the *PSAC Works For Women* course was held in Kingston at the Donald Gordon Centre in honour of National Day of Remembrance and Action on Violence against Women. Topics discussed included feminism, "Herstory", and PSAC's gains for women. Guest speakers included sisters from the Kingston District Labour Council and City Council.

Barrie - On December 6<sup>th</sup> the Barrie Regional Women's Committee gathered with friends and family to honour the lives of women who have been murdered and negatively impacted by violence in their homes and communities. The evening included a smudge, a reading and candle light ceremony, as well as an update on the Sisters in Spirit campaign. The committee continues to support women's shelters, Take Back the Night events and condemns all forms of violence against women and girls.

Thunder Bay - The Thunder Bay Regional Women's Committee and the District Labour Council co-hosted a vigil on Saturday December 6

to mark the 25th anniversary of the Montreal Massacre. Sheila Karasiewicz, Aboriginal Representative on the PSAC Ontario Council provided a lesson about the faceless corn-husk dolls in memory of the 1200 missing and murdered aboriginal women in Canada.

## **International Human Rights Day**

The PSAC Toronto Racially Visible Committee held a celebration commemorating International Human Rights Day on December 10, 2014. Members were invited to the PSAC Toronto office to hear guest speakers: Sebastian Rodrigues, National Vice President for Human Rights CEIU, Anna Liu - Asian Canadian Alliance (ACLA), and Chris Ramsroop - Justicia for Migrant Workers.

## Item 5. <u>PSAC Ontario Regional Office – Updates</u> (Christopher Wilson, PSAC Ontario Regional Coordinator)

The Ontario Region remains a very active region supported by a dynamic collective of staff.

#### **Staffing**

**Rita Cantalini** returned to work in her capacity as Administrative Assistant in the Toronto Regional Office effective Friday, January 9th, 2015.

**Denise Morrison's** term as acting Administrative Assistant in the Toronto Regional Office was extended until March 31<sup>st</sup>, 2015 to facilitate a transition period for Rita's return to work. I have recommended a further extension until April 30<sup>th</sup>, 2015 after which time Denise will return to her substantive position as secretary. During Denise's acting assignment, Rita Cantalini will conclude her training on new operating systems.

**Kulvinder Bisla,** who was hired to backfill Denise Morrison during Rita Cantalini's leave, was awarded a new permanent position within the public service (Service Canada); consequently, her last day as term secretary was November 17th, 2014.

Following Kulvinder's end of term, **Karma Burkar** was the successful candidate to backfill Denise Morrison as term secretary in the Toronto Regional Office commencing January 5th, 2015 to February 13th, 2015 inclusive. Karma has been a member of PSAC for over five years and is currently the Vice-President of CEIU Local 613. Karma worked as an Administrative Assistant for Citizenship and Immigration Canada where she provided financial support services through the preparation and administration of the budget, contract processes and liaises with Finance section for the exchange of information. Karma volunteered for different committees within her workplace such as the Diversity and Employment Equity Advisory Committee and the Professional Development Network. Kara previously worked as a Hearing Support Assistant for Immigration and Refugee Board of Canada and as a Service Deliver Agent for

Citizenship and Immigration. Karma returned to her substantial position within the federal public service following the end of her term.

I am pleased to now confirm that Tim McIntyre was the successful candidate for the one (1) year term position as Regional Organizer backfilling for Shell Sweeney. His term will continue until March 11, 2016 during which time he will be assigned to work from the Toronto Regional Office. Tim's prior experience with union organizing included a successful campaign to organize Teaching Assistants/Teaching Fellows at Queen's University. Tim will ensure continuity in the position during Shell's leave.

A term Administrative Assistant position for up to 4 months has been posted in the Sudbury Regional Office for purposes of backfilling Colette Mann who is currently on leave. The position has a bilingual requirement.

## **Operations / Facilities**

PSAC Holdings ended the lease for the 177 Wellington location which was used as a campaign office during the organizing drives at Queen's University.

PSAC Holdings leased a new office location in Sault Ste. Marie to support an ongoing campaign to organize employees of the Slots at Sault Ste. Marie. The office is located at <u>473-477 Queen Street East</u> Sault Saint Marie, P6A 1Z5. The suite # is 103.

## **Operations/Membership Database**

The process to update Unionware with membership self-identification information remains ongoing. Once completed this initiative with help facilitate communications between Regional Council members and equity members and young workers within the Region.

I have now received and reviewed the year-end 2014 Ontario Region financial report. Our Region incurred a small deficit of (\$17,141) on overall budget expenses for the 2014 Financial year including:

- Salaries

- Communication Expenses
- General Expenses
- Travel Expenses
- Sundry Expenses
- Meeting Expenses

This minor deficit is expected to be recovered at the end of 2015. At the end of 2013 our Regional Budget was within budget as a result of a number of cost containment and revenue measures our region which was a clear organizational priority. In 2014 our region was able to continue and maintain this record of fiscal responsibility. I will continue to monitor our Regional budget on a monthly basis in 2015 to ensure that we reproduce in same positive result this year while at the same time achieving our organizational objectives.

## Regional Office Branch (ROB) Review

The Regional Office Branch (ROB) Review has been completed with 51 recommendations. Sister Jeanne Baldwin, Sister Sharon DeSousa and Brother Bob Jackson are the three REVP's that has been assigned to review these recommendations. Work will start immediately following National Convention.

PSAC has done consultation within the organization and also with the membership, now the REVP's will be reviewing the ROB report from a political lens. Recommendations with regards to staffing will be based on the National Convention budget. Once review is completed an update will be provided to Ontario Regional Council.

Action Item: Provide an updated timeline when the ROB report will be completed.

# Item 6. Ontario Council Committee Reports

The Chair thanked the Health & Safety steering Committee for coming in early to help plan and organize the upcoming PSAC Ontario Regional Health & Safety Conference.

The Chair stated that all Committees are expected to take minutes during their meetings. The minute taker cannot be the person chairing the meeting. The reason for taking minutes is to ensure the Committee members are aware of the work discussed at that particular meeting.

Each committee is responsible for providing a report to the Ontario Council which is a summary of the activities between the Ontario Council meetings and provide recommendations to the Ontario Council. The Committee reports must be sent to the REVP's office after all members of the Committee have reviewed it and prior to the end of the meeting.

## Item 7. Ontario Council Members Reports (Appendix "E"):

 The Chair stated Sister Lynda MacLellan member of the Toronto Regional Women's Committee organized a letter writing campaign requesting a National Public Inquiry regarding the missing and murdered Aboriginal Sisters.

The Regional Office has made a computer terminal available in the organizing area, with versions of the 3 sample letters loaded for members to access and edit to their preference. The Toronto Regional Women's Committee would like to invite Ontario Regional Council and Observers to participate in the letter-writing campaign while they are here.

Once letters are completed, printed and signed by the member it can be placed in the box located on the desk. The Regional office Admin staff will ensure letters are sent out.

 Brother Richard McNeill stated that the Kingston region will be holding a Political Action dinner on June 13<sup>th</sup>, 2015. It will be a family event and other Unions will also be invited. Should the federal election be called at that time, candidates will be invited to speak at the event.

- Sister Sheila Karasiewicz attended the Toronto Regional Women's Committee meeting that was held on April 8<sup>th</sup>. Sister Karasiewicz had the opportunity to teach the Sisters how to make faceless dolls as part of the campaign for missing and murdered Aboriginal Sisters.
- Sister Lauren Baert stated a Young Workers Committee was recently started in the Greater Toronto Area (GTA). The Committee has been working tirelessly so that young workers can have greater engagement with their union.
- Brother Mike Decarolis stated he took part in a presentation surrounding the cluster of cancer rates within the Ambassador Windsor area. There is a copy of the presentation available if anyone would like to view it. Windsor is generally considered a high cancer region. This has terrible ramifications for communities and families in this area.

#### Item 8. Collective Bargaining Updates

The Chair stated that for the PSAC Day of Action on March 19<sup>th</sup>, a rally was organized at 4900 Yonge Street in Toronto. The building houses federal departments such as Public Works Canada, Service Canada and Department of National Defence. It is the location for many of the head offices. Brother Jerrry Dias, President of Unifor and Brother Mark Brown, from the Canadian Union of Postal Workers were guest speaker at the event, with over two hundred PSAC members' in attendance.

## Essential Services Agreement (ESA)

The federal government has brought in Bill C-4 which changes the consultation process of Essential Services Agreements (ESA). The Employer now has the power to go directly to members and let them know that they are considered essential. As well there is no consultation with the Union as was past practise. Also when the Union objected to the ESA for a particular group they had the opportunity to go to a third party, Public Service Labour Relations Arbitrator, who would hear both sides and provide a decision. The Employer has sole determination over the process.

There is a 10% increase in the number of members who are deemed essential since the last round of bargaining. Selected members will be given designation letters by the employer which they will have to present at picket lines. This letter allows them to cross the picket line and so they can continue to work.

There was a recent Supreme Court ruling in Saskatchewan which states the right to strike is protected by the Charter of Rights and Freedoms. This ruling will help PSAC with our Charter challenge to provisions in Bill C-4.

## Statistical Survey Operations (SSO)

The Chair stated that the Statistical Survey Operations (SSO) members won a wage increase of 9.6%, as well as job protection and security over the life of their collective agreement. This is a major win for PSAC members, who have been working hard in getting their message across by holding rallies and speaking to the media.

#### Canada Revenue Agency (CRA)

Sister Melanee Jessup provided an update on bargaining at the Canada Revenue Agency (CRA). Sister Jessup stated the bargaining team met with the employer on March 30<sup>th</sup> - April 1<sup>st</sup>, 2015, yet there is still disagreement on key issues, so no tentative agreement was reach at the end of the day. Both parties have agreed to meet May 20<sup>th</sup> and 21<sup>st</sup> in Ottawa in an effort to reach an agreement.

CRA members held a successful Day Action on March 18<sup>th</sup>. Another Day of Action is planned for April 30<sup>th</sup>. Along with rallies to keep members informed in regards to bargaining updates, there was a telephone town-hall held for all CRA members to take part in recently.

# Treasury Board

Sister Lauren Baert stated a Memorandum of Understanding (MoU) was signed by PSAC and Treasury Board (TB) to establish a joint task force on improvements to mental health provisions within the workplace.

The joint task force which is made up of an equal number of union and employer representatives, is tasked with the responsibility of implementing the measures to improve mental health within the workplace. Such measures include identifying ways to reduce and eliminate the stigma associated with mental health, and improving communication on mental health challenges within the workplace.

#### Canada Border Services Agency

Sister Baert stated that the Frontier Border Services (FB) bargaining unit has a significant number of operational issues that they will continue to push at the table. One key issue is to be treated with the same respect as other law enforcement personnel, by getting access to a retirement regime that reflects the work they do.

Sister Baert is also a member of the Sick Leave Common Issues Committee. The employer gave a presentation in regards to the new sick leave provision they would like to introduce. The Committee sent back a strong message that PSAC will not bargain away our sick leave.

The Chair stated that there were two Days of Action events on February 19<sup>th</sup> and March 19<sup>th</sup> in Ottawa in front of the Prime Minister's office. The events were well attended.

The PSAC Ontario Region is also keeping members informed by holding town-hall meetings that have received great responses from members about the information presented.

## **Parks**

The Parks Bargaining Conference was held in January. The bargaining team is schedule to meet with the Agency on May 26<sup>th</sup> – 28<sup>th</sup>. The PSAC Ontario regional banner was signed by Ontario Regional Council members and observers and the banner will be sent to the bargaining team.

<u>University of Ontario Institute of Technology (UOIT)</u>
Sister Marie Polgar-Matthews stated the team is heading into bargaining and has received some media coverage. The employer continues to ignore the bargaining team proposals.

<u>Canadian Corps of Commissionaires Kingston Division</u>
Sister Peggy Jones stated that the employer has walked away from the table stating that they will be applying for conciliation.

#### Blue Water Bridge

Brother Hassan Husseini is the assigned negotiator, the team will be starting bargaining shortly.

#### Police Sector Units

Anishinabek (APS) and Nishnawbe-Aski Police Services (NAPS) are still in negotiations.

#### Treaty Three Police Service

The employer is not recognizing the arbitration decision to bring the officers rate of pay in line with the Ontario Provincial Police officers.

#### Item 9. <u>Labour Day</u>

Labour Day will be highly political this year due to the upcoming Federal Election. The Labour Day proposals template will be sent out shortly to Area Councils and to isolated locals who do not have an Area Council in their area.

A bright yellow t-shirt colour was selected by the Ontario Council for this year's upcoming Labour Day celebrations.

# Item 10. PSAC National Triennial Convention 2015

The Chair introduced the National Executive Vice-President, Brother Chris Aylward.

Brother Aylward spoke on the National Pre-Convention Budget of 2016-2018, that will be presented on Convention floor later this month. The Finance committee had broken down the budget calculations into a three step process.

1. The Finance Committee looked at the estimated number of members for the next three years, which they have determined is 175,000. Then the Committee looked at the Component's

- estimated membership numbers, which they determined is 175,000. The Committee took into account possible future cuts to the membership as the government is clear that more cuts are coming.
- 2. The Committee then looked at the average salary of the membership. The average salary of the membership is going down as a result of PSAC losing members through cuts that are at a higher salary level and new members being organized have often lower salary levels. The average salary that was used for the 2016 calculation was \$49,688 allowing for an increase of 1.5 percent per year.
- 3. Once the Committee had the membership numbers and the average salary, they then looked at the dues rate. The result was a no dues increase budget.

The average salary is lower than what was anticipated in the prior budget cycle, which resulted in a shortfall in revenue of approximately 3.5 per cent. PSAC has had to find savings because of this shortfall. The Directors team was tasked with the responsibility of finding savings within their branches.

PSAC currently has six internally restricted funds and the Convention Finance Committee is proposing to the NBoD by way of resolution, to only have four internally restricted funds. The four internally restricted funds are:

- 1. Social Justice Fund (SJF) \$300,000 to carry out SJF work
- 2. PSAC Holdings This is a fully own subsidiary of PSAC and the Convention Finance Committee is requesting \$1.1 million to be allocated to the fund. PSAC Holdings fully owns the PSAC building headquarters at 233 Gilmour St., in Ottawa and the PSAC London Regional Office. It also oversees the leasing contracts for the other PSAC Regional offices across Canada.
- Resolution Fund \$1 million was allotted to the resolution fund at the 2012 Convention. The Convention Finance Committee is asking for \$750,000 to be allocated to the fund. This fund is to pay for resolutions from the Convention floor which have a onetime cost.

4. Transition Fund – The Convention Finance Committee is requesting to allocate \$4 million dollars to this fund. The fund will be used to restructure the organization, so that staffing is lined up with the priorities of the organization.

PSAC National Convention Finance Committee has two concurrent resolutions.

1. Issue Advance cheques for PSAC members with Disabilities to participate at fully funded functions.

The Committee recognizes the importance for PSAC to ensure a barrier-free environment for members with disabilities.

2. Strike pay increase.

The Committee recognizes the financial realities of members during a strike action, especially in the North. PSAC has one of the best strike pay rates in the labour movement.

The Chair thanked Brother Aylward for taking time out of his busy schedule to speak with on Ontario Regional Council on the Finance Committees recommendations to the PSAC National Triennial convention. Brother Aylward stated that he will be re-offering for a second term as National Executive Vice-President.

## Item 11. Ontario Council Newsletter

The Ontario Council newsletter which was started in 2011 has been very successful and Ontario Council would like to see the newsletter continued.

Brother Bob Black, Sister Missy Taylor and Brother Steve Tuffin volunteered to write articles for the upcoming newsletter.

Motion: Ontario Council survey be sent back to the subcommittee for editorial changes. m/s/c Marie Polgar-Matthews and Peggy Jones

Sister Claudia Espinoza asked how the decision of creating an Ontario Council survey came about and if Council is using their resources in the best way.

Point of Order – Sister Donna Struk stated that the motion has been passed and Sister Espinoza is still debating the motion.

# Item 13. <u>Canadian Labour Congress (CLC) Election</u> <u>Conference</u>

The Canadian Labour Congress (CLC) Election Conference was an excellent training session. The PSAC Ontario Region had over 60 participants attend the conference. The CLC will be holding a similar 3 hour session module in the near future in select regions.

The Chair stated that the CLC will be holding a telephone town-hall and would like to remind all PSAC members and staff to take part in this very important town-hall meeting.

Brother David Carr noted that the CLC National President, Brother Hassan Yussuff, went around the room and introduced himself to every person that was present at the conference.

# Item 14. Leadership Training

The Chair stated that there will be a make-up session for members that were unable to attend the Leadership training that was held at the Delta Meadowvale in January.

So far PSAC has delivered leadership training regionally and nationally. A review by the Standing Education Committee of the National Board of Director will be done of both training models and necessary changes will be made to the leadership training. After all Regional and Component Conventions are completed the next leadership training will be delivered in 2017.

## Item 15. Special Guest Speaker

The Chair introduced the National President, Sister Robyn Benson.

Sister Benson stated she had a meeting with Tony Clement in regards to Mental Health in the workplace, to which Tony Clement stated he would like to do something in regards to the issue. Sister Benson reminded Tony Clement that PSAC currently has a demand at the table concerning Mental Health in the workplace that is waiting on him to sign off on.

Sister Benson stated that PSAC members' need to get more fired up over all the cuts and changes that the Harper government has implemented in the last few years. PSAC's "We Are All Affected" campaign is still relevant, and the membership needs to continue talking with friends, family and community allies about the Federal Election.

Sister Benson stated that she is seeking re-election as the National President. Currently she is the only declared candidate. Sister Benson is looking for the support of the membership for another term as National President, to continue the fight for the members and all Canadians.

The Chair thanked Sister Benson for taking the time to speak with Ontario Regional Council.

### MANDATE OF THE EDUCATION COMMITTEE:

The PSAC Ontario Regional Council is committed to a dynamic, relevant and accessible education program for all PSAC members in Ontario. To this end the Education Committee of the Ontario Regional Council shall:

- actively promote the education program of the Alliance and the Alliance Facilitators' network (AFN);
- identify current educational needs, anticipate emerging issues and seek broad based input into the Regional Educational Plan;
- review and discuss issues related to PSAC education in Ontario and where applicable make recommendations for the consideration of the full Regional Council;
- develop creative strategies for the delivery of PSAC
   Union education and training within locals, work sites,
   the union and the community;
- on behalf of the Council work collaboratively with the REO and staff from the various Ontario Regional Offices in the development and implementation of the Regional Education Plan, including the appropriate program allocations from the Regional Education Budget;
- maintain an active liaison with the Ontario AFN (Alliance Facilitators' Network).

### **COMPOSITION OF THE COMMITTEE:**

The Committee shall be comprised of one Regional Council member from each of the geographic areas of Ontario (as described in the Regional Council ByLaws). In addition the Regional Education Officer shall be a full member of the Committee and serve as the Committee's technical support person.

The REVP shall appoint a Chairperson and Co-Chairperson from amongst its members. The Chairperson shall be responsible for the following:

- in conjunction with the REO and in consultation with the REVP call regular meetings of the Committee;
- Chair all meetings of the full Education Committee and name any Chairperson(s) of any Education subcommittees;
- report on the Committee's progress to the Regional Council;
- maintain accurate records of the Education Committee's meetings and education recommendations that have been adopted by the Ontario Regional Council.

Members of the Education Committee shall be responsible for the following:

- representing the educational needs of their geographic areas;
