Ontario Provincial Election



The date has been set for the 2018 Ontario election, which will take place on June 7, 2018. There is a lot at stake in this election for our members, and for every family in Ontario.

The Liberals have privatized Hydro One, sending electricity rates skyrocketing, introduced back to work legislation for college faculty, and had several political

scandals that undermine their credibility. On the other hand, with the pressure and advocacy of unions and community groups, we have seen a raise in the minimum wage and improved labour laws that protect workers.

The Progressive Conservatives (PC) have pledged to slow down the rise in the minimum wage and promised they wouldn't undo the progressive changes to workers' rights. Yet, their past record has shown that their interests and objectives are focused on corporations more than people.

The NDP have introduced a number of bills to make protections for workers even better. However, the Liberals and Progressive Conservatives (PC) have consistently voted them down. The question for the NDP will be whether they can motivate their base, while connecting to voters that have traditionally voted Liberal or PC.

This election is anyone's to win, and the next few months will be interesting. Regardless of the Party that is chosen, our members will stand strong and use our voices to make sure that the elected government works for our interests. We will continue to show our power in the streets and in our workplaces and make our communities better.

The Importance of Lobbying



The idea of lobbying has always made me a little nervous. What is it really? How do you do it? Well I can say, I will never be nervous of this again. I had the opportunity to visit my Member of Parliament in Ottawa in December with my Regional Executive Vice-President, Sharon DeSousa. I can say that although at first I felt a little intimidated it was well worth it. I will certainly be doing this again.

The topic of discussion was the Phoenix disaster. I am one of the many members who has suffered with Phoenix paying me incorrectly. I am underpaid, overpaid and missing pay. I had made the incorrect assumption that my MP would know all about this; he did not. Although he knew some basics he really did not understand. What I learned was that MPs who have higher concentrations of federal employees in their ridings have a stronger idea of the problems, but realistically many MPs do not.

I wanted my MP to know the real magnitude of the problem, the hardships this causes, the mental anguish that I have carried since 2016, when I was first struck by pay issues. He needed to know so he could be my voice in Parliament.

Lobbying is not what I expected but participating in this lobby was empowering. I encourage everyone to take the time to visit, write or call their MP's office. If you are nervous I would recommend reaching out to your PSAC Regional Office to find out more information on how to proceed. We need to lobby our MPs to ensure Phoenix is fixed and that our membership is fairly compensated for this ordeal.


A Time in Union History - It wasn't that long ago that.....

Paid maternity leave benefits have only been around since 1971 in Canada. Before that, a new mother had to quit her job or return to work soon after the baby's birth. The federal government, through the unemployment insurance program, introduced 15 weeks of paid maternity leave in 1971 at 66% of a mother's previous salary.

However, Unions began negotiating longer paid maternity leave with higher levels of benefits for their members soon after. Unions also began negotiating guarantees that women could return to the jobs they held before their maternity leave, helped secure paternity leave, and leave for parents who have adopted children.

On November 23, 2017, to coincide with the scheduled date of the release of the third Public Interest Commission mediation session, a rally was held outside of Finance Minister Bill Morneau's constituency office in Toronto. Rallies for a fair contract were also held by CIU members in Cornwall, in Niagara Falls, in Hamilton and in Windsor.

The more we demonstrate that we are willing to take action, the more we pressure our employer to treat us with respect.

The Mount McKay service was started in 1995 by WWII Veteran Pte Frank Banning of the Lake Superior Scottish Regiment, as a way to honour and shine light on Aboriginal Veterans who until then were not recognized at memorials.

December 6 – National Day of Remembrance and Action on Violence Against Women in Canada

On December 6, 2017, members of the CEIU Ontario Regional Women's Committee and the PSAC Toronto Regional Women's Committee attended the candle-light vigil ceremony to mark the National Day of Remembrance and Action on Violence Against Women in Canada.

This marked the 28th Anniversary of the Montreal Massacre that took the lives of 14 young women, who were murdered for simply being women. This year also focused on the thousands of missing and murdered Indigenous women and girls.

The event took place outdoors, on a chilly December evening, at the Philosopher's Walk at Bloor Street and Avenue Road in Toronto. The event was organized by a women's group called Women Won't Forget and consisted of an Indigenous healing ceremony, speakers, musical and spoken word performances.

The names of the women who were murdered by men in Ontario in 2017 were all read aloud and honoured and some of the committee members took part in this presentation. The ceremony ended with roses being placed on a rock in front of the symbolic headstones, bearing the names of the murdered women: "It is the job of those of us who go on living to speak for them and to change the world we live in" (Womenwontforget.org).
